A Proclamation against priuate Challenges and Combats : With Articles annexed for the better directions to be vied therein, and for the more iudiciall proceeding against Offenders.



He slaughters which We find to haue bene strangely multiplied and increased in these later times, by the boldnesse which many of Our Subjects take, to challenge any man into the Field, towards whom they carry either grudge or malice in their minds, under the pretext of satisfaction to pretended wrongs, without implying any respect of the Lawes, as Count Dagistrates: haue moued vs, out of the tender care which we take of Our loyal Subjects liues, to enter into these private combats for the stopping of a Blame that breeds both unchristianly, and unwarlike. For to speake truth, to what purpose serues the Lawes of God, the pensionall instructions of men, and the

courts of justice: Either in the Common lawes (whether they respect the Court of Chancery, or the Civill Courts,) if it be free for Subjects out of the bitterness of their owne distemperd conceits, either to raise the quality of the wrong supposed, or the condition that belongs to it: Besides, it were great pittie that so many Judgements as in other things they graunt and moderation, should be so strangely beverted, and as it were enclined in the hands that the very daggers of Cruelty, (considering consideration into passion, reason and appetite, and men into beasts) as to thinke that any graine of worth or reputation as true honour, can be disburied out of any one that is absolutely repugnant to all Lawes (as well Divine as humane) as they both Arguments and Policies. For as no man attempts his Honour of high estate, before it haue bene shewn by others no more our Gentlemen esteemed for their valour by the greater part of goodie countries as this day, that haue not almost as much as they can hold a sword in their hands, put themselves upon their power, either in St. Georges fields, or at Finbury, without the least respect to the Justice of the ground that should make good the purchase of the quarrell.

We are not ignorant in what degree slaughters upon private Challenges are raised by the Lawes of the land. (Howebeit stricke be made the matter) nor how earnestly many noble persons are to make their owne wills absolute in some points, since they knowe not by what colour of pretence to command in all, nor how cunningly some as pose for excuse of Challenges, by imposing the benefite (as they would haue vs apprehend) to the Lawes and Statutes of the Realme; as that they forbear either out of inconsideration or neglect, to give satisfaction to some certayne wrongs and injuries, as for example to that of the Eye, which the custome and construction of the lawes in which they haue both marched with those wrongs that are reputed to be most excusable: For though no private Challenge to the perill of a loyal Subjects life, be either well or compatible with

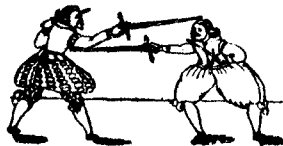

INTRODUCTORY NOTE.

Mr Forbes Sieveking's valuable contribution to a field of literary research which notwithstanding its many attractions still remains relatively neglected needs, I am sure, no commendation on my part. To begin with, this scholarly edition, alike instructive and suggestive, of a very curious and very creditable specimen—shall I say of University wit or of wit suitable for University consumption?—will be welcomed by many Cambridge readers as a pleasant reminiscence. Last summer, the performance of *Worke for Cutlers*, when Sword, Rapier and Dagger carried on their subtle contention in the open, set the crown upon the pleasant hospitalities of a Long Vacation afternoon spent in the congenial surroundings of Trinity Hall. And, remembering how near we were to Clare and Trinity and St John's, some of us could not on the occasion repress the wish that in these days, when there is so much theatre of one kind or another, 'shews' bringing to mind the polite recreations of our predecessors were more frequent; and that the revival *in loco* of this 'merry dialogue' might lead to the reproduction of some full-blown specimens of a far from insignificant literary growth—our native academical drama. *Worke*

for *Cutlers* dates from a period in our University history signally memorable in respect of its efforts in this direction; for it was printed in the very year of the famous royal visit to Cambridge, during which among other plays *Ignoramus* and *Albumazar* were performed; and, when one comes to think of it, Oliver Cromwell, who is fabled to have filled a part in a much earlier academical comedy, only came up a year or so too late to have a chance of playing *Sword*. But the savour of this dialogue is of Court and Town as well as of the University; or perhaps it might be said that its matter is of the former, though its manner makes special appeal to the kind of trained intelligence necessarily abounding in the Universities and in the Inns of Court. Mr Forbes Sieveking has ventured on a highly ingenious conjecture which suits both ingredients in the product; but though I have every reason for welcoming any addition to the literary reputation of Thomas Heywood, I must for the present be content with advising that this Dialogue be placed in the Library of my College as a 'doubtful' work of one of its worthies. Thomas Heywood would have been capable of this *tour de force*, no doubt; for his range was wide, and his versatility was part, though not the most characteristic part, of himself.

The historical value of this little piece is by no means trifling; for, as Mr Forbes Sieveking has made clear, King James I.'s Edict against Duels gives its point to the discussion, and this Edict marks an important stage in the gradual evolution of a social reform for which there is reason enough to bless the Pacific King's

name. The literary characteristics of the dialogue are on the surface, but they deserve attention for their own sake. Just as so large an amount of professorial insight into the entire philosophy and art of the practice of single combat was sure sooner or later to lead to its ultimate suppression as a national institution or custom—so an excess of verbal wit which overlaid everything with its too well-meant efforts could not but stifle what dramatic possibilities there lay in such a dialogue. In truth it is best enjoyed in print; and to do itself full justice, it needs the expenditure of technical and antiquarian lore which it has been fortunate enough to receive at the hands of its present editor.

PROLOGUE.

The following reprint of what, taking a hint from Beaumont and Fletcher, may be called a Combat of "Wit at several Weapons," or, in still earlier language, a "Wappenschaw"—is from one of the rarest of early English plays, if so minute an opuscle may assert a claim to so dignified a title. My attention being drawn to *Worke for Cutlers* in the modernised version of the *Harleian Miscellany* (10 vols. 4°, 1808—13)¹, I at first naturally accepted the current belief that the only known copy of the original (of which this is an exact line-for-line and word-for-word reproduction) was the one in the British Museum.

But the bibliographical curiosity of my friend, Mr M. Compton Mackenzie of Magdalen College, Oxford, discovered another example in the Library of Worcester College, and the courtesy of its Librarian, Mr H. A. Pottinger, has enabled me to identify a twin copy, alike in all respects.—The first reprint with modernised spelling was given in vol. x. of the *Harleian Miscellany* under the editorship of Thomas Park, with the following brief introduction:—

That punning species of gladiatorial wit, with which the following dramatic dialogues abound, is likely to have procured them academical admirers, in the time of our first James, when scarce a word—

"to royal favour had pretence

But what agreed in sound, and clashed in sense."

The particular occasion which introduced these pieces as parts of a University shew does not appear: but they are curious specimens of the taste of a former age in its scholastic entertainments.

It was next, I believe, reproduced (evidently from the copy of 1615) by Mr Charles Hindley with other tracts, under the general title of *Miscellanea Antiqua Anglicana* and the better known sub-title of *The Old Book Collector's Miscellany*, 3 vols. (Reeves and Turner). In vol. 2 is also given another *Merry Dialogue* on precisely similar lines, evidently from the same hand, or some other deliberately imitating it—the very turns of the sentences and the expressions and phrases bearing a close resemblance. Its full title is as follows:—"A Merry Dialogue between Band, Cuffe and Ruff.—Done by an excellent wit, and lately acted in a Shew in the famous Universitie of Cambridge. London, printed by W. Stansby for Miles Patrick and are to be sold at his Shop neare Saint Dunstone's Churchyard in Fleet Street, 1615" (11 pp.). This is also contained in the same vol. of the *Harleian Miscellany*¹.

But between these two issues of *Worke for Cutlers*, allusion had been made to it in an able and original article in the *Retrospective Review*, as follows:—

The Returne from Parnassus was called by its Author a *Show*. In 1615 another was performed, entitled *Worke for Cutlers*...its author is unknown, and the interlude itself almost equally so; it may be classed among the very scarcest of the early English dramas².

The title may have been inspired by Thomas Dekker's *Worke for Armourours: or The Peace is broken* (1609), from which I take the following extract bearing upon our subject:

"Cutlers and Armourers have got more by them (the Hollander and

the *Spaniard*) within these few yeares, then by any lowly Nation (besides them) in Christendome all their whole lives."

A few words of speculation in regard to the unknown author may perhaps be allowed me. Having no reputation for historical scholarship to jeopardise, I venture to hazard the daring opinion that this *Merry Dialogue* may be from the pen of no less a dramatist than Thomas Heywood himself. So much for irresponsible free-lancedom in dogmatic criticism—*credo, ergo est*. Having, however, a certain respect for what amongst lawyers is called "the weight of evidence" (with whatever levity of argument it may be adduced), I feel it desirable to give my sparse reasons as concisely as possible for the faith that is in me.

1. There is evidence that Thomas Heywood was at one time a resident at Cambridge; and it is probable that he was a member of Peterhouse. Wm Cartwright says definitely that he was a Fellow of that College.

By Heywood's own confession, (in the Preface to the *English Traveller*), he had a hand in no less than 220 plays. "This tragic comedy, (being one reserved amongst 220) in which I had either the entire hand or at least a main finger, coming accidentally to the press." Moreover he was notoriously careless of his own fame, living or posthumous, although he is unwilling to let the play in question pass as "*Filius Populi—a Bastard without a father*." He continues, "True it is that my plays are not exposed to the world in Volumes, to bear the title of works (as others)"—Charles Lamb comments "he seems to glance at Ben Jonson"—one reason being that "many of them by shifting and change of companies, have been negligently lost—others of them are still retained in the hands of some actors who think it against their peculiar profit to have them come in print, and a third that it never was any great ambition in me to be in this kind voluminously read."

Upon this, Charles Lamb, who first threw open to us moderns the gates of the rich and royal domain of Elizabethan drama, makes this further remark:—

Of the 120 pieces which he here speaks of as having been concerned in, only 25, as enumerated by Dodsley, have come down to us, for the reasons assigned in the preface. The rest have perished, exposed to the casualties of a theatre. Heywood's ambition seems to have been confined to the pleasure of hearing the players speak his lines while he lived. It does not appear that he ever contemplated the possibility of being read by after ages. What a slender pittance of fame was motive sufficient to the production of such Plays as the *English Traveller*, the *Challenge for Beauty*, and the *Woman Killed with Kindness*! Posterity is bound to take care that a writer loses nothing by such a noble modesty.

Heywood, indeed, seems to have regarded it almost as a dishonest act to print his plays as well as to act them; for in the Preface to his *Rape of Lucrece* (fourth impression 1630) he makes the following explanation:

Though some have used a double sale of their labours, first to the stage, and after to the press, for my own part, I here proclaim myself ever faithful to the first, and never guilty of the last: yet since some of my plays have, unknown to me, and without any of my direction, accidentally come into the Printers hands, and therefore so corrupt and mangled, copied only by the ear, that I have been as unable to know them, as ashamed to challenge them.

And in the Prologue to a play of his, entitled *If you know not me, you know nobody*¹ (1623 edition), Heywood has the following lines:

'Twas ill nurst
And yet receiv'd as well perform'd at first,
Grac'd and frequented; for the cradle age
Did throng the seats, the boxes, and the stage,
So much, that some by stenography drew
The plot, put it in print, scarce one word true:
And in that lameness it has limp'd so long,
The author now, to vindicate that wrong,
Hath took the pains upright upon his feet
To teach it walk, so please you sit and see it.

2. In Heywood's *Apologie for Actors* dated 1612 we read in book 1:

In the time of my residence in Cambridge I have seen tragedyes, comedyes, historyes, pastorals, and *Sberues* publicly acted in which the graduates of good place and reputation have been specially parted.

(Note that he uses the very word *Showe* applied to this *Merry Dialogue*.)

3. Heywood was the author of a play called *Cutting Dick* now lost (see Epilogue, p. 62).

In the text (page 42) Rapier says "Did you nere heare of *Cutting Dicke*, this is the very same man."

This, I contend, has very little point, unless Heywood was either the author of *Worke for Cutlers*, the player of the part of "Sword" or both.

4. As Heywood was one of Her Majesty's (Queen Anne's) Players, in which capacity he attended her funeral, nothing is more probable than that he may have been in James I.'s train, when he visited Cambridge in 1615; and if he were the author of the play (which in certain respects may be regarded as a "skit" upon James I.'s Edict against Duels), there would be every reason for his not acknowledging the authorship; and the possible suppression of copies when printed after the performance would account for their rarity.

5. In others of Heywood's few extant works I find several of the puns and expressions recurring—e.g. that on "Matches" in his play *If you know not me, you know nobody*, 1605.

I think I have met with a better commodity than Matches, and my master cannot say *but he hath met with his match*.

And later on in the same play the word "match" is again punned upon.

6. 'S foot and God's foot are favourite oaths with Heywood, whereas Shakspeare, I believe, only once employs this form of strong speech¹.

7. The *Dagger in Cheap* is not of frequent mention in the contemporary dramatic literature, but I do find it spoken of elsewhere by Heywood: e.g. 2nd Prentice in *If you know not me* &c. (1605). p. 76 *post*.

The "Dagger" in Holborn was a far better known hostelry and more often alluded to. In the notes I give my reasons for believing that "the Dagger in Cheap" was not in "Cheapside" itself as usually asserted by later commentators, but in Foster Lane, Cheapside (though in Farringdon Ward); and I fancy that "Cheap" is always, or nearly so, used as a district or ward, and not as an individual street.

8. I seem to trace in Heywood's earlier extant works an enthusiasm for the sword and the exercise of arms (notably in his *Foure Prentises of London*, first printed in 1632 but written 15 or 16 years before, thus bringing it very near the date of our Dialogue) which is in keeping with this supposed authorship: thus for instance:

Eustace. "I am a Grocer: Yet had rather see
A faire guilt sword hung in a velvet sheath
Than the best Barbary Sugar in the world"

or:—

"I would fast from meate and drinke a Summers day
To see Swords clash, or view a desperate fray"

or again:—

"I am no sooner got into the Fencen-Schoole,
To play a venew with some friend, I bring;
But *Eustace, Eustace*, all the street must ring."

I admit that the aggregate of these crumbs of collateral argument does not form a solid crust of proof; but as the great Charles Darwin once said to me (when I told him that a certain Doctor was commonly regarded as a Dane, because he was appointed physician to the Princess of Wales on her first coming to England):—"The world accepts many things of greater importance on more slender evidence".¹

As an instance of this, I find it stated in Fleay's *Chronicle of the English Drama (1559—1642)* that the *Siege of London* is assumed to be

Heywood's by Collier, Halliwell, the *Biographia Dramatica* and Gildon—"I know not why," comments Mr Fleay, "unless it be that in Sc. II. Hobs the Tanner says: 'Dost thou not know me? then thou knowest nobody'."

With the further remark that the following entry of the publication of the Dialogue is to be found in the Stationers' Registers—

and that its printer, Thomas Creede, was also the printer of the first Quartos of *Richard III.* (1598), *Romeo and Juliet* (1599) and *Henry V.* (1600), his name being found frequently in the Stationers' Register between the years 1593 and 1616¹—I now leave this part of my subject to the credulity and criticism of my readers.

I should have liked to adduce a few more historical and enlightening facts in regard to the ancient City Gild or Company of Cutlers; but it is well known that its records, owing chiefly to the Great Fire, are not capable of yielding a very fertile crop of information as to its early history and connection with the *Dramatis Personae* of the dialogue. There is the well-known passage in Stow's *Survey*:—

In Horsebridge Street is the Cutler's Hall. Richard de Wilehale 1295 confirmed to Paul Butelar this house and edifices in the Parish of St Michael &c....paying yearly one clove of Gereflovers (gilliflowers) at Easter. They of this Company were of old time divided into three arts or sorts of workmen: to wit, the first were smiths, forgers of blades, and therefore called bladers, and divers of them proved wealthy men....The second were makers of hafts, and otherwise garnishers of blades. The third sort were sheathmakers, for swords, daggers and knives. In the 10th of Henry IV. certain ordinances were made betwixt the bladers and the other cutlers, and in the 4th of Henry VI. they were all three Companies drawn into one fraternity or brotherhood by the name of Cutlers.

I subjoin a few more early references to them from H. T. Riley's *Memorials of London*:—

Also,—in order to avoid deceit of the people in this behalf, be it ordained that no handle of wood, except *digron* shall be coloured."

Every knife is prepared separately by 3 different crafts, first the blade by Smiths called *Bladsmytbes*, the handle and the other fitting work by the Cutlers, and the sheath by the Sheathers.

A joint petition of Cutlers and Bladesmiths showing that foreign folk from divers parts of England counterfeited and forged the marks of the Bladesmiths free of the City.

And in the same year the Articles of the Bladesmiths declared

that every person of the said trade who is a worker or maker of lance-heads, swords, daggers or knives must make the points and egges thereof hard throughout to stand the assay; on pain of forfeiture thereof; also that every master shall put his own mark upon his work. 10 Henry IV., A.D. 1408.

In a letter dated 28th April, 1580, from William, Lord Burleigh, to the Lord Mayor, we read how:

He had caused search to be made among the Cutlers in Westminster for swords and daggers exceeding the length limited by her Majesty's Proclamation.

Finding some disorders there in having blades in their shops contrary to the said Proclamation, the Cutlers had excused themselves, alleging that others of the same trade in London sold both swords and daggers exceeding the length prescribed. He requested that search should be made, and no one permitted to have any blades in their shops not reformed according to the before mentioned Order (*Remembrancia of the City of London*)¹.

And the following passage from Greene's *A Quip for an upstart Courtier* (1592) shows that the average Cutler's morality was not beyond suspicion:

And you, cutler, you are patron to ruffians and swash-bucklers, and will sell them a blade that may be thrust into a bushel; but if a poor man, that cannot

skill of it, you sell him a Sword or a rapier new overglazed, and swear the blade came either from Turkey or Toledo.

Let us now pass to the consideration of the state of duelling in England prior to and at the period of our Dialogue, and the weapons by which an appeal to arms in private quarrels was decided.

The duel, as is well known, sprang out of the ancient "Trial by Combat," in which the weapons appointed were "Gleyve, long-sword, short-sword and Dagger". According to Dugdale², after the bill of challenge is delivered with a gauntlet to the Court by the appellant and the defendant has accepted the gauntlet and denied the point of the bill, the place is appointed, and the lists and counter lists (for the marshals) are set up. The appellant appeared at the east gate of the lists, "where he is admitted to enter by the Marshall himself, together with his Arms, Weapon, Victual, and also his Council with him: and then is brought to a certain place within the lists, where he attends the coming of the Defendant." The marshal then measures the weapons, administers the oaths, the lists are cleared, and the constable and marshal, sitting at the King's feet, pronounce these words with a high voice: *Lessez (Laissez) les aller; Lessez les aller; Lessez les aller et faire leur devoir*³.

In the reign of Henry VIII. (A.D. 1540) we find first mention of a corporation of the Maisters of the Science of Defence: but there is a MS. in the British Museum⁴ forming a Chronicle (believed to have been compiled under Elizabeth, but commencing in the reign of Edward VI.) of a recognised and chartered body, consisting of

Masters, Provosts and Scholars, who formed a sort of College or Guild of Arms, bound by indentures, oaths, "ruills and constitucons." This Guild conferred degrees of proficiency upon its members after a system of practical examinations, tested by competitions at each stage of their professional careers.

The pardon craved for a "Scholar's Prize," in the tag at the conclusion of the Dialogue, undoubtedly alludes to "the Order for playenge of a Scholler's Prize," which consisted in his competing with at least six scholars at the long-sword and back-sword "for a tryall or prooffe," before his admission as "a free Scholar"—and 7 years later he was qualified to play his Provost Prize, for which promotion he had to show proficiency with the two-hand sword, the back-sword and staff "with all manner of Provosts,"—the final degree for a Master's Prize being conferred upon his showing mastery of the two-hand sword, the bastard sword (sometimes now called the "hand and a half sword"), the pike, the back-sword, and the rapier and dagger. The last entry in the book is dated 1583, soon after which date a proclamation of Elizabeth dissolved the guild, in the interests of the peace and "good manners."

To take these weapons in their order of priority in the Dialogue.

The word Sword, besides its present generic meaning, implied in its earlier specific sense a heavy edged weapon used almost entirely for cutting or hacking, and generally wielded, or, in the case of the lighter bastard sword, capable of being wielded, by two hands: and it is clear from several passages in the text of the Dialogue, that even as late as the year 1615 the old conservative view of a two-handed sword being the genuine British weapon still prevailed, and that the pointed rapier was looked upon in the dubious light of a foreign *parvenu*. I am indebted to Mr Edwin Ward¹ for an analysis of the Dialogue from this point of view, and I venture to quote his letter at length, as it helps

to a better understanding of the relations of the two disputants (Sword and Rapier) and their umpire (Dagger):

The very existence of this work proves what a popular topic was the relative merits of these weapons at this period. In the Dialogue, I presume "Dagger" represents the general public opinion, and though he acknowledges the good points of both weapons, yet he evidently had strong leanings towards the classic two-handed sword as representing the king of arms with a noble pedigree, though confessing "Rapier is a Souldier, and a Man as well armed at all poynts as anie one." The only detrimental statement Dagger makes with regard to Sword is "Away Sworde, the Time was indeed when thou wast a notable Swashbuckler, but now thou art growne olde Sword." I take this to mean that about the time 1615, duels or contests, fought out with the large knightly two-handed sword, were of far less frequent occurrence than in the previous century, owing to the handy rapier having usurped the duties of the noble sword in this respect. Dagger seems to regret this from a sentimental point of view; his regard for Sword comes out later on in "Sworde, by the very sounding of his name, should bee the better Gentleman &c.," and in the same breath "Rapier hath but one arme," meaning to contrast this fact with the two hands of the sword, which he does in plain words later on. This comparison, however, viz., "You know you are two handed Sworde, and Rapier has but one hand,...and yet youde have him go into the Fieldes with you," seems to be the beginning of the peroration or judgment of Dagger, who wishes to bring the discussion to an amicable settlement in favour of the sword, and thus magnifies the discrepancy between the two arms to please Sword, intending afterwards to easily "square" the tricky *parvenu* Rapier, by telling him since duels are put down (implying of course that in these he was of consequence) that he can assume the rôle of an elegant ornament and rest in peace, but that after all for serious fighting in warfare, the sword was "the weapon." One could almost imagine cheers from the ultra-conservative portion of the "house" greeting this statement. The most impartial statement made by Dagger is "Your both of one blood, only thers this difference, that Sword comes of the elder brother, and you Rapier of the younger." I consider this statement important, as Dagger admits a connection of Rapier with the true sword, two-handed even, and does not look on him as a rank outsider.

I venture to endeavour to trace this suggestion in two expressions elsewhere in the Dialogue, viz., first words of Rapier.... "Nay Backe-Sword" and also "Alas I haue knowne you beare a Basket Sword." Rapier of course means to be insulting, but yet the word "sword" is coupled with Backe- and Basket as if usual expressions, and Rapier further in these expressions insinuates that even the great Sword family stepped down sometimes from their high pedestal of "two-handedness" (if this

Erinism may be permitted) to adapt themselves to the more handy form of a Backsword or Basket sword; is this the transition from the science of simple sweeping strokes to the intricate one of fencing?

Without laying any weight on the above statements, I think the word "sword" was evidently used to designate the cutting weapon, either two-handed, or back or basket variety, the first most legitimately; the rapier, though possibly indirectly connected with the parent sword, was so far removed as to be considered a distinct weapon (thrusting being its essential point) and therefore incorrectly or loosely named, when called a sword. I consider you establish a fresh point in bringing into prominence the prestige of the large two-handed weapon, which seems to be generally thought of as something abnormal, and not as it appears to have been, the recognised standard arm of the soldier of Elizabethan and previous times.

In the Middle Ages, the Sword was personal and personified. The sword of Charlemagne was called *Joyeuse*, that of Roland *Durandal*, that of Renaud *Flambaud*, that of Oliver *Hauteclair*. Roland addresses his sword at Roncevaux, so does Bayard after being knighted by Francis I. and the Cid in the *Romancero*.

"La grande épée à mains brille au croc de la selle,
La hache est sur le dos, la dague est sous l'aisselle."

Victor Hugo, *Eviradnus*.

The first introduction of the Rapier into England is attributed, on the authority of Camden, to Rowland Yorke in the year 1587¹.

It is "probable that Diez's solution (rejected by Littré) is right and that *rapiere* is for *raspiere*, a name given in contempt, meaning a rasper or poker. Hence also a *proking-spit* of Spaine = a Spanish rapier (Nares). Cp. Span. *raspadera* a raker from *raspar* to rasp, scrape." Skeat.

In Q^o I. of Hamlet, à propos the fencing scene, we find (Dowden's Edition),

"Mary, Sir, that yong Laertes in twelve venies (venues = bouts or thrusts)

At Rapier and Dagger do not get three oddes of you."

But, by the date of the following edition, the fashion had changed, foils are introduced, and a "Bragart Gentleman" has developed into the Euphuistic "Water-fly" Osric.

This Yorke is commonly regarded as a traitor for having deserted and fought on the Spanish side in the Low Countries, surrendering a fort of which he was governor near Zutphen to the enemy. Camden's account may be read in two versions, either in that of Abraham Darcie's translation from the French of P. D. B. in the 1625 edition of Camden's *Annals of Queen Elizabeth*, or in the 1688 edition of his *History of Princess Elizabeth*, and I select the former for quotation for the sake of its more vigorous English:—

"This Yorke, borne in London, was a man most negligent and lazy, but desperately hardy; he was in his time most famous among those who respected Fencing, having been the first that brought into England that wicked and pernicious fashion to fight in the Field in Duels, with a Rapier called a Tucke¹, onely for the thrust: the English having till that very time, used to fight with Backe-swords, slashing and cutting one the other, armed with Targets or Bucklers, with very broad weapons, accounting it not to be a manly action to fight by thrusting and stabbing, and chiefly under the waste."

As early as 1590 we find Sir John Smythe, in his *Discourses on matters Militarie*, inveighing against the preference shown by "armed men Piquers" (Pikemen) who "rather weare Rapiers of a yard and a quarter long the blades or more, than strong short arming Swords and Daggers... which they cannot with any celeritie draw, if the blades of their swords be so long."

Thus it seems clear that Sir Frederick Pollock is in the right when he traces the parentage of the two-edged rapier to the "military sword of all work in the form it had assumed in the first half of the 16th century, lengthened, narrowed and more finely pointed²."

In introducing the fascinating and perfidious dagger, (of which the author last quoted thinks the thrusting-sword is only the extension, but I venture to submit that its etymology proves it an abbreviation from a longer weapon), I cannot deny myself the pleasure of trying to repro-

duce that fine piece of inlaid and polished prose, in which Paul de Saint Victor¹ eulogises this most incisive and penetrating of weapons:

"The dagger, which is a shortened glaive, or a lengthened poignard, was called in the 14th century *Misericord*, because, thrust at the throat of an overthrown adversary, it forced him to ejaculate its name. In the 16th century, the dagger no longer goes to war; it becomes a duelling arm—terrible and traitorous; now parrying the rapier-thrust, anon insidiously insinuating itself into the openings of fence, to deal the adversary a 'coup de Jarnac': sometimes the dagger, naked and smooth to the eye, hid within itself a trident: two little lateral blades, incorporated with the central one, bifurcated under pressure of a spring hidden in the shoulder. 'Twas a viper protruding its triple tongue of venom."

A very different type this poignard or stiletto from the

"Long heauie Daggers, with great brauling Ale-house hilts (which were never used but for private fraies and braules, and that within less than these fortie yeres (i.e. 1550—1590) since which time through long peace, we have forgotten all orders and disciplin Militarie) they doo no waies disallow, nor find fault withall, but rather allowe them for their Souldiers to weare, than short arming Daggers of convenient forme and substance, without hilts, or with little short crosses, of nine or ten inches the blades, such as not onely our braue Ancestors, but all other Warlike Nations, both in War and peace did weare, and use²."

In conclusion, we have to say something as to the strong attitude which James I. took up against duels. By constitution James was no friend to steel and its uses; for although it may be an exaggeration to contend that the fashion of bombastic trunks and quilted doublets was entirely due to his ever-increasing fear of assassination, there is reason to believe that he did not always carry out his own admonition to his son in the *Basilikon Dōron* "to wear no ordinarie armour with your clothes but such as is knightly and honourable; I mean rapier,

swordes and daggers"—although he certainly has the sense to include fencing amongst the exercises he 'would have' him 'to use.' As early as 1612 he had allowed one of his Scottish nobles to be sentenced to death, (a sentence duly carried out,) for the murder of a fencing master; and the measure of the King's earnestness is shown in the Proclamation issued on the 13th May, 1612, offering £500 for the person of the said Lord Sanquir living or £300 for his person dead; whereas the body of Robert Carlisle, a Scottish Borderer and the instrument of murder, was assessed at £100 living or his carcase at £50, so that evidently at that time one Scottish Baron was equivalent to five or six Scottish Borderers: but something may have been added for his being a handsome fellow, and a few pounds again deducted for a "hair-scarre or cut on his lippe up to his nose, which made him snuffle in his speech," whereas the Lord Sanquir was "of a reasonable tall stature, pale-faced of a sallow colour, a small yellowish beard, one glasse or false Eie," the outcome (or the ingoing) of the rapier or dagger of the murdered man Turner. *Proclamation Book* (Record Office).

The case is reported in the State Trials as

"The arraignment and Confession of the Lord Sanquire, (who being a Baron of Scotland, was arraigned by the name of Robert Creighton Esqre) at the King's-bench Bar, in Westminster Hall, the 27th of June, for procuring the Murder of John Turner, a Master of Defence, whom he caused to be shot with a Pistol, (*cum pulvere bombardico et glandine plumbea*) by one Carliel, a Scottish-man, for thrusting out one of his Eyes in playing at Rapier and Dagger. 10 James I., A.D. 1612¹."

Lord Sanquhar (Sanquire or Sanchar) in his defence said:

"The first motive of this fatal accident was that Turner playing with me at foils, now about seven years past at my Lord Norris's House in Oxfordshire put out one of my eyes, and that (as my Soul and Conscience was over-persuaded) willingly and of set purpose. At the taking up of the foils I protested unto him I played but as a Scholar, and not as one that would contend with a master in his own profession...the order whereof...is to spare the face...I request that the king may be fairly informed of the sincerity of my confession.

Sir Francis Bacon (S. G.). I conceive you have sucked those affections of

duelling in malice rather out of Italy and outlandish manners. His Maj^{ty} hath shown himself God's true lieutenant and that he is no respecter of persons, but English, Scots, nobleman, fencer, (which is but an ignorant trade) are all to him alike in respect of justice."

In 1613 we have James's famous Edict against Duels (annexed to the Royal Proclamation, of which the Society of Antiquaries possesses a copy¹ and the State Paper Office none), which Isaac Disraeli declares "exhibits many proofs that it was the labour of his own hand." Indeed we have James's own word for this in his later Proclamation of 25 March 1616 "against Steelets, Pocket Daggers, Pocket Daggess and Pistols," wherein he speaks of "Our Edict proceeding from our pen" having "put down and in good part mastered that audacious custom of Duellos and challenges"; but, curiously enough, he does not include the Edict in the folio of his own works published in the same year.

The Proclamation plunges straightway into "The Slaughters which we find to haue been strangely multiplied and increased in these later times by the boldnesse which many of Our subjects take to challenge any man into the Field." The royal remedy for "the stopping of a Vaine that bleeds both incessantly and inwardly" was that the striker should "condemn under his own hand the saucy paradox which gives liberty to gentlemen with their own swords to revenge their wrongs." He was further to promise solemnly to the Lords never to offend again, and be bound over for 6 months to good behaviour, during which time he was to be banished from the Court; and he was moreover to be subject to an action of Battery at common law: the things being "cumulative rather than privative."—We give in the Epilogue (pp. 83—85) samples of the royal argument and its expression, but it is with con-

siderable logical shrewdness that James questions why Englishmen, who had imported the fashion of duelling from foreign states, were not consequent in following their precedents, which were now turned against duels'. The 'Action of Battery' finds a distinct echo in the text of the Dialogue.

But it was not merely in Proclamations and Edicts that James's strenuous determination to eradicate the duelling propensity showed itself. At the sitting of the Star Chamber, on 26th Jan., 1615, with a bench consisting of the Archbishop of Canterbury, the Lord Chancellor, the Lord Privy Seal, the Lord High Admiral, the Lord Chamberlain, the Bishop of London, the Treasurer, the Comptroller and the Vice-Chamberlain of the Household, the Lord Chief Justices of England and the Common Pleas and the Chancellor of the Exchequer—the grave question of a challenge to fight at single rapier, the length of which was shown on a stick, came before the Court, which "with one consent did utterly reject and condemn the opinion that the private duel in any person whatsoever had any grounds of honour; as well because nothing can be honourable that is not lawful, and that it is no magnanimity or greatness of mind but a swelling and tumour of the mind when there faileth a right and sound judgment²."

This case is perhaps less memorable for all the weight of intellect upon the Bench, than for the fact that the charge was delivered by Sir Francis Bacon, the King's Attorney General, and may be found reported in Vol. II. of his works: and from this I extract the following specimens of his forensic eloquence and argument:—

".....The proceedings of the great and noble commissioners martial I honour and reverence much, and of them I speak not in any sort. But

I say the compounding of quarrels, which is otherwise in use by private noblemen and gentleman, it is so punctual, and hath such reference and respect unto the received conceits, what is before-hand, and what is behind-hand, and I cannot tell what, as without all question it doth, in a fashion, countenance and authorize this practice of duels, as if it had in it somewhat of right."

".....But, my Lords, the course which we shall take is of far greater lenity, and yet of no less efficacy; which is to punish, in this Court, all the middle acts and proceedings which tend to the duel, which I will enumerate to you anon, and so to hew and vex the root in the branches, which, no doubt, in the end will kill the root, and yet prevent the extremity of law.

.....But for a difference to be made in case of killing and destroying man, upon a fore-thought purpose, between foul and fair, and as it were between single murder and vied murder, it is but a monstrous child of this latter age, and there is no shadow of it in any law divine or human.

.....And of this kind was that famous example in the wars of Naples, between twelve Spaniards and twelve Italians, where the Italians bare away the victory; besides other infinite like examples worthy and laudable, sometimes by singles, sometimes by numbers.

.....Therefore now to come to that which concerneth my part; I say, that by the favour of the king and the court, I will prosecute in this court in the cases following. If any man shall appoint the field, though the fight be not acted or performed. If any man shall send any challenge in writing, or any message of challenge. If any man carry or deliver any writing or message of challenge. If any man shall accept or return a challenge. If any man shall accept to be a second in a challenge of either side. If any man shall depart the realm, with intention and agreement to perform the fight beyond the seas. If any man shall revive a quarrel by any scandalous bruits or writings, contrary to a former proclamation published by his majesty in that behalf.

Nay, I hear there be some Counsel learned of Duels, that tell young men when they are before-hand, and when they are otherwise, and

thereby incense and incite them to the duel, and make an art of it. I hope I shall meet with some of them too: and I am sure, my lords, this course of preventing duels is nipping them in the bud, is fuller of clemency and providence, than the suffering of them to go on, and hanging them with their wounds bleeding as they did in France!"

We also read in a ms. letter from John Chamberlain, preserved in the State Paper Office, dated 26th Feb. 1626, and addressed to the Rt. Hon. Sir Dudley Carleton, Bt., Ambassador to the United Provinces at the Hague:

The King was expected at the Star Chamber, whether he went the day after the Terme (13 Feb.) and there is a case of Challenge twixt two youths of Ynnes of Court, Christmas and Bellingham, tooke occasion to make a Speech about Duells wherein he was observed to bestowe many goode words on the Spanish nation, and to gall the French more, w^{ch} he since interprets to be only touching that point. I heare no certaintie yet whether we shall have yt in print, the issue of all was that the gentlemen (who could say little or nothing for themselves) were fined at a 1000 £. apeece and imprisonment in the towre during pleasure.

And here, abruptly enough, breaks off my Prologue. Duels are 'violent delights,' which—sometimes—"have violent ends." How otherwise were Baudelaire's phrase, *bizarre comme le duel*, or James I.'s *Bewitching Duels* so full of felicity?

Should any reader resent and challenge this want of ceremony, I must retain a far greater lawyer—the learned Selden—who in one of his many 'Titles of Honor'—*The Duello*—pleaded:—

“Reader, I open not a Fence-school, nor shall you here learn the skill of an Encounter, or advantageously in the lists to traverse your ground”—nor, I trust, the ground of my lowly Argument.

And if at all the *Manes* of Heywood become dimly conscious of a literary dwarf clambering on to the dramatic giant’s shadowy shoulders; or (to shift my figure for his own) fathering upon him a base-born *Filius Populi*, let him too remember that by not signing his multifarious writings, he has become an accessory before the fact to many a later literary larceny—and also let him recall the final words of one of his own signed Prologues “Read perfectly, Examine strictly, but Censure charitably”—

*whereof I desire
To make my pen th’ adoptive sire.*

I have tried to set my poor wits upon the best strops at hand, and while I dare not hope that this “Worke,” even if accepted as sharpened and pointed on Heywood’s whetstone, will strike out as many sparks of popularity or make as much noise in the world as the wheel of Canning’s “Needy Knife-Grinder”—a *Feu d’Esprit* of a similar temper of cultured cutlery—at least it is possible that one or two Master Grinders may appreciate the labour, (may be, the merit,) of the *Cos exors ipsa secandi*.

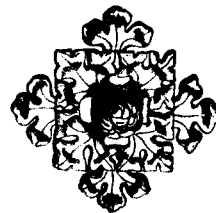

Sword.

Ay *Rapier*, come forth,
come forth I say, Ile giue
thee a crowne, though it
be but a crackt one: what
wilt not? art so hard to
be drawne forth *Rapier*?

Enter



Enter Rapier.

10 *Rapier.* S'foot thou shalt know that *Rapier* dares enter: nay *Backe-Sword*.

Enter Dagger, he holds Rapiers hands behinde him.

Rapier. Whose this behinde me?

Dagger. Tis *Dagger* fir; what will you neuer leaue your quarrelling?

Rapier. Well *Sword*, *Dagger* hath defended you a good many times; but tis no matter, another time shall serue: shall I get
20 you out *Sword* alone, that I may haue you *Single-sword*.

Sword. Yes if youle be single *Rapier* too.

Dag. Nay *Sword*, put the *Cafe* of *Rapiers* aside, that there were two of them, I hope you were able to buckle with them.

Sword. Ile tell you what, if I goe into the Field with him, hang *Sword* vp if I doe not cut *Rapiers* poynts, and lash him when I haue done: nay, you shall finde *Sword* mettle to
30 the very backe: 's foot, my teeth be an edge at him.

Dag. If you offer but to thrust towards him

him *Rapier*, Ile strike you downe.

Sword. Hang him, I defie him bafe *Spaniard*.

Rap. Defie me? firrha *Sword*, *Rapier* spits i' thy face: dar'ft meete mee i' the fields, crauenly *Capon*?

Sword. *Capon*?

Rapier. I *Capon*, fo I say fir.

Dagg. Why any man may see that thou art well caru'd *Sword*; and yet mee thinks that *Rapier* should not speake of that, for it's an hundred to one if he be not gilt too.

Sword. Well *Rapier*, if thou goest into the fields with me, Ile make a *Capon* of you before I haue done with you, you shall nere come home vncut Ile warrant you.

Dagger. Nay, you shall finde *Sword* a notable *Cutter*.

Rapier. He a *Cutter*? alas he nere went into the fields yet, but he was foundly hackt before he came out.

Sword. Nere talke you of hacking, for it's a hundred to one if you haue not the *Foyle-Rapier*.

Rapier. 'S foot if you be fo *Short-Sword*, *Rapier* nere feares you: come a long.

Dagger. Nay nere goe, for if you doe,
Ile

60 He sende one after you, which shall scowre you both. The *Cutler* can doe it. I haue seene him handle you both brauely.

Sword. The *Cutler*, Alas wee are the best Friends hee has, and if it were not for vs, the *Cutler* might soone shut vp his shoppe.

Dagger. Alas *Sword*, you need not talke of his shutting vp of Shoppe, and if it had not beene for him, you had broken by this time *Sword*, Nay, nere talke: For you know
70 hee can holde your nose to the Grind-stone, when hee list.

And as for you *Rapier*, you knowe hee brought you vp first, and if you had stayed with him still, it might haue bene better for you.

Rapier. Better for mee? Alas hee knewe not how to vse mee.

Dagger. Hee vsde you too well indeede: for when you were with him he furnisht you
80 with Siler and euery thing, but now you are worne out of all fashon. You are euen like a Lapwing, you are no sooner Hatcht *Rapier*, but you runne abroad presently from him.

Rapier. Yet I scorne to runne away from him.

Sword.

Sword. But it were more wisedome then to stand: For the *Cutler* is a man as well Armed as any man I knowe, and has as good skill ins weapons. 90

Rapier. Ha *Sworde*, is the winde in that Doore? Faith nowe I see which waye you stand bent *Sworde*, you had rather sleepe in a whole skinne, then goe into the Fields to trye your selfe.

Sword. Syr, *Sword* has been prou'd before now, and yet heele prooue himselfe againe with you, if you dare follow him.

Dagger. Doe you heare *Sworde*? If you goe, looke for *Dagger* at your backs present- 100 lie; For I am a Iustice of Peace, and am sworne to keepe and defend the Peace.

Rapier. Syr, wee will fight, and doe you take it in *Dudgeon Dagger* if you please: if you once offer to hinder vs, He so Pummell you *Dagger*, that you were neuer better Pummeld in your life; And howsoever, I hope theres Lawe against you as well as others, and *Rapier* can put vp a *Cafe* against you. 110

Dagger. Alas I care not if you were both Plaintifes against mee, you shall finde *Dagger* your Defendant He warrant you:

I, and

I, and if neede bee, I could put vp an Action of Batterie against you.

Sword. What talke you of Law? *Sword* scornes to haue any other Law then *Martial* law, and that vpon you *Rapier*.

Dagger. Away *Sworde*, the Time was in-
120 deed when thou wast a notable Swash-buck-
ler, but now thou art growne olde *Sword*.

Rapier. I, you doe well, to excuse his Cowardise.

Sword. Why Sir, tis well knowne that *Sword* has flourisht in his dayes.

Dagger. Flourisht? yfaith Syr I, I haue feene *Sword* hang with nothing but Scarffes ere now.

Rapier. With Scarffes? with a Halter, if
130 he had beene well seru'de. For hees a nota-
ble Theefe. *Dagger.* A Theefe?

Rapier. I, a Thiefe.

Did you nere heare of *Cutting-Dicke*, this is the very same man.

Dagger. Nay *Rapier*, nere hit *Sword* ith teeth with that: for you know you were both Indited for treason before now, and were in danger to be hangd, and drawn too, and had escapt well if you had not bene quarterd.

140 *Sword.* I hope knows how to keep his quarters.

Dagger. You are a craftie *Foxe Sword*: It
were

were well if you knewe howe to keepe your friendship too, for Gentlemen and Friendes should not fall out.

Sword. *Rapier* a Gentleman?

Rap. A Gentleman? and has Armes.

Dag. But mee thinkes *Sworde* by the very founding of his Name should bee the better Gentleman, and has the better Armes too: for if the truth were well knowne, *Rapier* hath 150
but one arme.

Rapier. *Sword* beare Armes? Hees a base companion. Alas I haue knowne you beare a Basket *Sword*.

Dag. If you looke ith booke of *Armorie*, He warrant you, you shall finde *Sworde* of more antiquitie then you *Rapier*: Hee deriues his Pedigree from *Morglay*, *Beuis of South-hamp-tons sword*; and that from S. *George his sword*, that kill the Draggon. 160

Rapier. I, the *dragon in Sussex*, the other day: But He warrant you *Rapiers* of as good a blood as hee for his hart.

Dag. Byth masse, I thinke indeed, you are both well fanguind. Your both of one blood, only thers this difference, that *sword* coms of the elder brother, & you *Rapier* of the yōger.

Rapier. And oftentimes the younger brother prooues the better Souldier.

Dag.

170 *Dagger.* Nay, *Dagger* will defende you both for good Souldiers.

Swords. *Rapier* a Souldier? When did you ere knowe *Rapier* fight a Battell?

Dagger. Yes *Rapier* is a Souldier, and a Man as well Armed at all poyntes as anie one.

Sword. No, no, its *Sworde* that's the notable Souldier; Why, theres none of all you Captaines could doe anie thing in Warre
180 without him.

Rapier. I hope *Rapier* hath not beene at Fencing-Schoole all this while for nothing.

Dagger. Alas there's none *Maijster of Defence* but *Dagger*: But yet if you speake of Souldiers, the'rs Bow, Bill, and Gunne, worth twenty such as wee are.

Rapier. Indeed they say that *Bow* has bin an olde Souldier.

Sword. Yet hees not fit for a Souldier,
190 any man may bende him as hee list.

Rapier. And as for Bow-string, I dare vnder-
dertake to whip him my selfe.

Sword. Then let mee alone to tickle *Bowes* owne nocke yfaith.

Dagger. But what say you to *Bill*? hees a notable sturdy villaine.

Sword.

Sword. *Bill*, Ile pay him foundly, if ere I reach him.

Dagger. Its more then you can doe, Ime affraide; For *Bill's* a Tall-fellow ons hands, 200 and will quickly be Wood: and then theres *Gunne*, such another Bouncing-fellow too.

Rapier. *Gunne*, Alas hees No-body: any little Boy will make him roare.

I haue made him goe off 'oth Fieldes, a good many times my selfe.

Dagger. Well, is *Gunne* No-bodie? Ime sure hee giue some blowes sometimes.

Sword. Its' nere but when *Powder* ouercharges him, then indeed hee be somewhat 210 hote oth matter.

Rapier. I think that *Powder* is a vile bragger, he doth nothing but cracke.

Dagger. Faith I knowe not what Souldier hee is, but they say, Hees an excellent politician.

Rapier. Hee a Pollitician?

Dagger. Why, hee has an excellent wit?

Sword. Pish, Its nothing but a flash.

Dagger. Ime sure I can remember since 220 he was a Parleмент-man.

Rapier. Hee a Parleмент-man: For what Shyre?

Dag.

Dag. Nay ber-lady, it was for the whole Country.

Sword. I wonder they should chuse him: Why he does euery thing on the sudden.

Dag. Oh he plottes shrevvdly. If they had not look't too it, Hee had vndermined the
230 vvhole parlement-houfe.

Sword. I but hees No-body now-adayes, Hees blovvne vp long agoe.

Dagger. Well, if eyther you, or any body else shuld meete with Povvder, yet its a hundred to one, if he meete not vvith his match.

Rapier. Nay, you should let him alone
Dagger, and you should see that *Swords'* as notable a bragger as Povvder. He thinks hee shall nere be matcht too: but hee shall, and
240 ouer-matcht too, by *Rapier*; I vvarrant him. Come *Sworde,* after your long Parley, Dare you goe into the Fieldes?

Sword. Dare I? You shall soone see that: Goe, and Ile followv you.

Dag. Well saide, desperate *Dicke,* *Sword,* You may be asham'd to offer it. You knowve you are tvvo-handed-*Sworde,* and *Rapier* has but one hand (vnlesse I helpe him) to do any good vvithall, and yet youde haue him go
250 to the Fieldes vvith you. Come, theres neyther of you shall goe. Doe not you knowve that

that Duells are put downe?

Youle bee bound to'th Peace euer heere-after, if you strike but one stroke. Therefore you had best let me decide your controuersie for you.

Sword. Why, you are a backe-Friend to vs both *Dagger.*

Dagger. Nay, you knowe Ime equally allyed to you both, and therefore shall proue
260 an impartiall Iudge: How say you, will you be rulde by me?

Rapier. Nay let him choose, *Rapiers* at a good poynt, whether he will or no.

Dagger. Why are you so long *Sword* before you *speake*?

Sworde. Are duells put downe? Then I am forc'de to be Friends: *Speake* then.

Dagger. Then in briefe it shall bee thus. *Sworde,* you shall beare Chiefe force ith
270 Campe, and be made Generall of the Field, to beare sway euery where. As for you *Rapier,* since Duells are put downe, you shall liue quietly and peacable heere 'ith Court, and goe euery day in Veluet: You shall be Friends with euerie one, and bee on euery ones side, that if occasion serue, and *Sworde* be absent, so that matters are driue to a push,

Rapier

Rapier shall be the onely man to performe a
 280 Combate: And I my selfe will backe you
 both, as occasion shall serue.

How say yee, are yee content?

Rapier. Wee are.

Dagger. Then goe before to my House,
 to the Dagger in Cheape: and there weele
 conclude all.

Rapier. A Long-Sword.

Exeunt, Swords and Rapier.

Dagger.

290 Our weapons drawne, and yet no hurt yee finde,
 Did Dagger then defend unto your minde?
 Hee that defended others not long fence,
 At last hee dares not stand ins owne defence;
 But this hee hopes, with you it will suffice,
 To craue a pardon for a Schollers Prize.

GLOSSARIAL EPILOGUE.

(The numbers bracketed indicate the lines of the Dialogue on pp. 37-48.)

Crack'd Crown (5).

"*Ingenioso*. I may chance, indeed, give the world a bloody nose, but it shall hardly give me a crack'd crown, though it gives other poets French Crowns." *The Returne from Parnassus*, or the *Scourge of Simony*, publicly acted by the Students of St John's Cambridge, 1606.

Pummell (105). "The tang (or tongue of the sword), which is of many shapes...ends in the pommel or 'little apple' (*le pommeau, il pomolo, der Knauf or Knopf*) into which it should be made fast by rivets or screws. The object of this globe, lozenge, or oval of metal is to counterpoise the weight of the blade, to prop the ferient of the hand, and to allow of artistic ornamentation." Burton's *Book of the Sword*, p. 124. Its further object was for use like the butt-end of a musket, to "pummell" your adversary.

Dagger at your backs (100). It was for some time the fashion to wear the dagger hanging at the back, cf.:

"This dagger has mista'en, for lo his house
 Lies empty on the back of Montague."

Romeo and Juliet v. 3.

According to Nares, the rapier and dagger were usually worn side by side.

"His sword a dagger had, his page,
 That was but little for his age:
 It was a serviceable dudgeon
 Either for fighting, or for drudging:
 When it had stabb'd, or broke a head,
 It would scrape trenchers, or chip bread."

Hudibras l. 1. 375.

Also:

"Thou must wear thy sword by thy side,
And thy dagger handsomly at thy back."

The longer thou livest &c., 1570.

Dudgeon (104). See Nares's "Glossary." A peculiar kind of handle to a dagger, made of the root of box—the *Cambridge Dictionary* of 1693 has "A dudgeon-haft—manubrium apiatum or buxum"; see too Gerard's *Herbal*, in Johnson's edition, under *Box-Tree*: "Turners and Cutlers...doe call this wood *dudgeon*, wherewith they make *dudgeon-hafted* daggers." Also *Macbeth* II. 1:

"I see thee still,

And on thy blade and dudgeon, gouts of blood."

Beaumont and Fletcher's *Coxcomb* v. 1:

"A dudgeon-dagger will serve him to mow down sin withal."

1611. "Dague a roelles—a Scottish Dagger—a Dudgeon haft dagger. Cotgrave." (Murray.)

The root of the box-tree was also called *dudgeon* from being curiously marked, "the root (of box) is dudgin or full of work." Holland's Pliny B. XVI. c. 16. (Skeat.)

Evelyn does not mention the dudgeon haft, but speaking of *Beech* he says: "Of the thin *Lamina* or *Scale* of this wood (as our Cutlers call it) are made *Scabards* for Swords." *Sylva*, chap. v. 2.

Mr Guy Francis Laking writes to me *à propos* of the hilts of the daggers (nos. 1324 and 1334) in the Wallace Collection "To the best of my belief the grips of the daggers you name in the Wallace Collection are of box-wood."

Francis Junius in his *Etymologicum Anglicanum* (ed. by Lye, Oxon. 1743) has the following:

"*Dudgeon haft*. Manubrium apiatum [Dudgeon, Pugiuncula à Teut. Dolch Pugio q.d. Dolkin vel à Degen, Gladius. Skin.]."

Pugio, a dagger, hence It. *pugnale*, Fr. *poignard*.

"O plumbeum pugionem." O leaden dagger, *i.e.* O weak argument; Cicero.

1380. *Ordinance for Cutlers*. "Lond. in Letter Book H... of. cxviii., 'Que nulles manches darbre forsque *digeon* soyent colorez.' (tr. in Riley, *Mem. London*, 1868), see Arnold's *Chronicle*. (1811), 245." Murray's Dictionary.

"From stabbing of arms, flap-dragons &c. good Mercury defend us."

Backsword (11). A sword with only one cutting edge.

1611. Cotgrave. "*Badelaire*, a short and broad Back Sword."

1750. Bolingbroke. *Pol. Tracts*, 214. "The backsword of Justice which cuts only on one side."

2. A stick with a basket-hilt used instead of a sword in fencing, a single-stick.

"Yet I confesse, in old times, when blowes were only used with short Swords and Bucklers and back Sword, these kind of fights were good and most manly, but now in these daies fight is altered."

Single-Sword: Single Rapier (21). "At the Single Sword, Sword and Dagger and Sword and Buckler, they forbid the thrust, and at the single Rapier and Rapier and Dagger they forbid the blow" (*i.e.* cut).

...If the thrust be best why do we not use it at the single Sword... If the blow be best, why do we not, use it at the single Rapier, Rapier and Poingard?" *Ibid.*

Raper. Philip Stubbes in *The Anatomie of Abuses* says "Swordes Daggers and rapers of bare iron and steel were as handsome as they, and much more conducive to that ende whereto swordes and rapiers should serve."

The Buckinghamshire Rapers originally spelt their name Rapier. *Memoirs of a Highland Lady.*

Case of Rapiers (23). "The case of Swords as it was termed in England, implied a right and left handed sword that were worn together in the same Scabbard. Giacomo di Grazzi, the Fencing Master, writing in 1570 speaks of their use with enthusiasm. The fight with the case of Swords much resembled that of the Sword and Dagger, with the exception that the longer weapon in the left hand made its action more offensive. It was taught by the Masters Agrippa and Marozzo in the middle of the 16th Century."

Guy Francis Laking, F.S.A., *Catalogue of Armour in Wallace Collection*, and Egerton Castle and Captain Hutton *passim*.

Rapier and Dagger. "I have seen it disallowed that a gentleman challenged to fight with rapier and dagger should present himself in the equipage of a man at Armes; or that another should offer to come with his cloake instead of a dagger." Florio's Montaigne, II. 26.

Rapiers at a good poynt (263). "But whan a man perceiveth that he is entred so farre that hee can not drawe backe without a burdeyne, hee muste, bothe in suche thinges he hath to doe before the combat and also in the combat be utterlye resolved with hymselfe, and always shewe a readineses and a stomake¹. And not as some dooe, passe the matter in arguing and *pointes*², and having the choise of weapon, take suche as

have neyther poynte nor edge¹. And arme themselves as though they shoulde goe against the shotte of a Cannon."

The Courtier (Sir T. Hoby's Translation).

"Let us be at a poynt what is best to be done."

Macheth IV. 3. 135.

Buckle (25) = engage in close fight: Shakespeare, 1 *Henry VI.* I. 2. 95; v. 3. 28 too strong for me to buckle with, IV. 4. 5; 3 *Henry VI.* I. 4. 50.

"*Lambert.* And, Serlsby, I have there a lusty boy,
That dares at weapon buckle with thy son."

Friar Bacon and Friar Bungay, Sc. XIII.

Cut Rapiers poynts (28) and *Points*. "Foresleves of velvet, called in those days poignetting of a doublette." *Institution of a Gentleman*.

"Then he brought him to a Mercers shop, and said to the Mercer let me see of your best silken pointes, the Mercer did presently show him some of seaven groates a dozen...then he said to the Maister of Defence, there is one dozen for you, and here is another for me."

Silver's *Paradoxes*.

"Laces or ties frequently having ornamental tags and as often used in the 16th and 17th centuries, so profusely employed to secure different parts of dress, as to form a trimming, sometimes to make quite a fringe."

Draper's Dictionary.

Like their supersessors, pins, they were chiefly manufactured at Bristol, "Bristolwles great trade is the making of points, and that was the chief mystery that was exercised in the town."

Stafford, *Compendious Examination &c.*, 1581.

Shakespeare also puns upon the word in *Twelfth Night*—

"*Clown.* But I am resolved on two points.

Mar. That if one break, the other will hold; or if both break your gaskins will fall."

"Truss my points, Sir."

Eastward Hoe, 1605.

Lash (28). "Ouerlashing in apparel is so common a fault, that the very hyerlings of some of our Players, jet under gentlemen's noses in sutes of silke" &c. Stephen Gosson, *School of Abuse*, 1579.

"*S foot* (10 and 57). "One sware me God from top to toe with our breath...the other...sware me by the flesh of God, that if sweating wite to help him but one ace, he would not leave one piece of God unsworn, neither within nor without." Ascham's *Toxophilus*.

"I know a man that will never swear but by *Cock and pye*, or *mouse-foot*. I hope you will not say these be oaths."

The Plaine Man's Pathway to Heaven. By Arthur Dent 1601.

"By the Mouse-foot, some give him hard words."

T. Heywood's *First Part of K. Edward the Fourth*.

"This infamous custom of Swearing I observe reigns in England lately more than any where else; though a *German* in highest puff of passions swears a *hundred thousand Sacraments*, the *Italian* by the *Will of God*, the *French* by his *Death*, the *Spaniard* by his *Flesh*, the *Welshman* by his *Sweat*, the *Irishman* by his *Five Wounds*, though the *Scott* commonly bids the *Devil hale his soul*; yet for variety of Oaths the English Roaver puts down all." James Howell, *Familiar Letters*, Aug. 1, 1628.

We here see the origin of three of the oaths familiar on the stage, viz. 's foot, od's Fish (Charles II.) and Zounds, are clearly "God's foot," "God's Flesh" ("How art thou Fishified!"), and "God's Wounds."

"God's body, God's body, my Lord Chancellor (Sir Thomas More), a parish clerk, a parish clerk!" Roper's *Life of Sir Thomas More*.

The Duke of Norfolk used "vain repetitions, as the Heathen do."

"*Dick Bowyer.* 's hart, and I lye, call me Jebuzite.

Peter. Bowyer a Captayne? a Capon, a button mould, a lame haberdine (salt cod), a red-beard Sprat, a Yellow-hammer...a very Jackdaw with his toung slit.

Bowyer. Zounds, what a Philistine is this."

The Tryall of Chevalry.

Jeremy Collier in his *Short view of the Immorality and Profaneness of the English Stage* (4th ed. 1699) has this upon 'Commuted' Oaths:

"Sometimes they mince the matter; change the Letter, and keep the Sense, as if they had a mind to steal a Swearing, and break the Commandment without Sin. At another time, the Oaths are clipped but not so much within the Ring, but that the *Image and Superscription* are visible...*Shakespeare* is comparatively sober, *Ben Johnson* is still more regular; And as for *Beaumont* and *Fletcher* in their Plays, they are commonly Profligate Persons that Swear, and even those are reprov'd for it."

There seems no doubt that much of the mincing and "clipping" of oaths such as "'s foot" etc. was due to the Statute against Swearing (3 Jac. I. c. 21) "for the preventing and avoiding of the great abuse of the holy Name of God in Stage-plays, Enterludes etc." which enacted a forfeit of £10 for each offence.

Base Spaniard (34). Cf. Ben Jonson's *The New Inn*, Act II., Sc. v.

Tip. Your *Spanish Host* is never seen in *Cuerpo*,
Without his Paramento's Cloak and Sword.

Fly. Sir, he has the Father
Of Swords, within a long Sword: Blade *cornish* stil'd of Sir *Rud*
Hughdebras.

Tip. And with a long Sword, bully Bird, thy sence?

Fly. To note him a tall Man, and the Master of Fence.

Tip. But doth he teach the *Spanish way* of *Don Lewis*?

Fly. No, the Greek Master he.

Tip. What call you him? *Fly.* Euclid.

Tip. Gi' me the *Moderns*. *Fly.* Sir, he minds no *Moderns*,
Go by, Hieronimo! *Tip.* What was he? *Fly.* The Italian
That plaid with Abbot *Antony* i' the Fryers,
And *Blinkin-sops* the bold. *Tip.* I' marry, those
Had Fencing Names, what's become o' them?

Host. They had their times, and we too say, they were.
So had *Caranza* his: so had *Don Lewis*, &c."

enemies: and this is the only lying to accomplish that kind of fight."

Eng. Marry, and welcome, sir, come on.

(They fight: he hurts the Spaniard.)

Spa. Holo, holo! thou hast given me the canvisado.

Eng. Come, sir; will you any more?

Spa. Signor Cavaliero, look behind thee. A blade of Toledo is drawn against thee.

(He looks back: he kills him.)

Short Sword (57). "If we will have this true Defence, we must seeke it where it is, in short Swords, short Staues, the halfe Pike, Partisans, Glaues (Glaives) or such like weapons of perfect lengths, not in long Swords, long Rapiers, nor frog pricking Poiniards."

Gilt (44). (*Equivoque gilt*.) "To these haue they their rapiers, swordes, and daggers, gilt twice or thrise ouer the hiltes with good angell golde, or else argented ouer with Siluer both within and without; and if it be true, as I heare say it is there be some hiltes made all of pure siluer it selfe, and couered with golde. Othersome at the least are damasked (damascened) varnished and ingrauen meruillous goodly; and least any thing shoulde be wanting to set forth their pride, their scaberdes and sheathes are of velvet, or the like; for leather, though it'se more profitable and as seemely, yet wil it not carie such a porte or countenance as the other."

Scower (*Scowre*) (60). "O' my conscience this Morning I beat twenty Higling-Women, spread their butter about the Kennel, broke all their Eggs, let their sucking Pigs loose, flung down all the Peds with Pippins about the Streets, scower'd like Lightning, and kick'd Fellows like Thunder: ha, ha, ha." Shadwell's *Scowers*, Act iv. Sc. 1.

"But it becommethe a gentleman (saye they) to be a Royster, whyche worde I doe not well understand onles it signifie a ruffian... And if sundrye things myght haue one name, then myghte a hatchet bee called a spade...for if a Gentleman haue in hym any humble behaour then Roysters do cal suche one by the name of a Loute, a Clynchepope, or one that knoweth no facions."

"A Ruffian and an unquiet man, geuen to quarels, such one as we cal a Roister."

The Institution of a Gentleman 1568 (reprint 1839).

In one of Marston's satires, *Reactio* (printed with his *Pigmalion's Image*, 1598), upon Bishop Joseph Hall, himself one of the earliest (if not the first after Skelton) and greatest of English satirists, we find

"Come, manumit thy plummy pinion,

And scower the sword of elvish champion."

The words in italics are said by Hall's editor T. W. Singer (1824) to be a paraphrase of Hall's own words in *A Defiance to Envy*. (Marston was Hall's Cambridge rival.)

"*Ralph*. 'I'll scour you for a goblet.' A slang term for chastise.

Dr A. W. Ward's *Dr Faustus*.

'I'll scour you with my rapier.'

Nym to Pistol. *Hy. V.* II. I. 60."

The *Scowers* were the "Mohocks" or "Rufflers" of their day. Their name forms the title of one of Shadwell's plays, wherein an old rake thus boasts of his early exploits—"I knew the Hectors, and before

them the Muses, and the Tityretu's; they were brave Fellows indeed! In these days, a man could not go from the Rose Garden to the Piazza once, but he must venture his life twice, my dear Sir Willie."

Scott's note to *The Fortunes of Nigel*.

"The bravo of the Queen's day...had, since the commencement of the Low Country wars, given way to a race of Sworders, who used the rapier and dagger instead of the far less dangerous sword and buckler."

Introduction to *F. of N.*

"Duels in every street were maintained: divers sects and peculiar titles passed unpunished and unregarded, as the sect of The Roaring Boys, Bonaventers, Bravadors, Quarterors and such like."

History of the First Fourteen Years of King James's Reign.

Somers's Tracts, ed. by W. Scott, vol. II. p. 266.

Sir Thomas Overbury has the "Character" of "A Roaring Boy."

"*Iudicio*. Methinks he is a ruffian in his style

Withouten bands or garter's ornament:

He quaffs a cup of Frenchman's Helicon

Then roister doister in his oily terms

Cuts, thrusts and foins at whomsoever he meets."

The Returne from Parnassus 1606:

first acted at St John's College Cambridge 1604.

Broken by this time, Sword (68). The *Equivoque* may partly turn upon the recollection of the Sword-Breakers (*brise-épées*) mostly of the fifteenth century, of which Sir R. Burton gives four illustrations on p. 138 of his *Book of the Sword*. They were made with a toothed or indented edge, found in Arab, Indian and other Eastern weapons. (See Wallace Collection.)

Furnisht you with Siler (80). See Note to *Gilt*, p. 58.

Fashion (81). "Fencing (Right honorable) in this new fangled age, is like our fashions, euerie daye a change, resembling the Cameleon, who

altereth him selfe into all colours saue white: so Fencing changeth into all wards saue the right."

George Silver, *Paradoxes of Defense*, 1599.

Silver (80).

"A Gull is he which while he proudly weares

A silver-bilted rapier by his side,

Indures the lyes and knocks about the eares

Whilst in his sheath his sleeping sword doth bide."

Lapwing (82). "This Lapwing runs away with the shell on his head."

"As the Lapwing runneth away with the shell on her head, as soon as she is hatched."

Hatcht (82). "Hatching" was the term for engraving and inlaying the hilts of weapons: and still survives as a technical term of engraving.

You stand bent Sworde (93). "As the sword of the best tempered metal is most flexible, so the truly generous are most pliant and courteous in their behaviour to their inferiors."

Is the Winde in that door (91) or, as we now say, "Sits the wind in that quarter?" Cf. Gifford's note to "Is the wind there" in Ben Jonson's *Bartholomew Fair*:—"A proverbial expression. 'Is it so?' 'Have I found you out?'"

"*Philologe*. What handling belongeth to the weather?

Toxophilus. Knowing of his wind with him, against him, side wind, full side wind, side wind quarter with him, side wind quarter against him and so forth."

Ascham.

Scarf (127). "First mentioned as an article of dress in the time of Elizabeth." Draper's Dictionary.

"Then must they haue their silk scarfs cast about their faces, and fluttering in the wind with great lapels at every end, either of gold or silver or silk, which they say they wear to keep them from sun-burning."

Stubbes, *Anatomic of Abuses*.

"The scarfed bark," *Merch. of Venice*.

Cutting-Dicke (133) seems to have been a lost play by Heywood.

F. G. Fleay (*Biographical Chronicle of the English Drama 1559—1642*, vol. 1., p. 290) has this entry: "1602, Sep. 2. Additions to *Cutting Dick* £1. This play must have been written before Worcester's men joined Henslow." Also in his *History of the Stage (1559—1642)* p. 155. "Cutting Dick, i.e. Dick Bowyer, the same as *The Trial of Chivalry*" (by Heywood and another), i.e. *The History of the Tryall of Chivalry with the Life and Death of Cavallero Dick Bowyer*, 1604, reprinted in Bullen's *Old Plays*.

Cutting Dick, so "*Val. Cutting*—a Roarer or Bully," one of the dramatis personae in *Bartholomew Fair*.

Cf. also Stephen Gosson's *The Schools of Abuse* (1579, ed. Arber). "The skil of Logicians is exercysed in caueling, the cunning of Fencers applied to quarrelling: they thinke themselues no Scholers, if they bee not able to finde out a knotte in every rushe;...Every Duns will be a Carper, every *Dick Swash* a common *Cutter*." (Here Duns may be *Duns Scotus* or *Dunce*, and *Dick Swash* may be the original of our *Cutting-Dicke*.)

Cutting and Cutter (50). "A certain Justice of Peace with a swaggering companion called Cutting Tom, who in a braverie took the wall of Mr Justice."

Jack of Dover (from a copy in Bodleian Library), 1604, Wm Firebrand, Percy Society, Vol. vii.

Gabriel Harvey in his "*Four Letters and Certain Sonnets, especially touching Robert Greene*" (1592) makes one of his accusations, "his

employe of Ball (surnamed Cuttinge Ball) till he was intercepted at Tiborne."

Cf. Cowley's *Cutter of Coleman Street*.

"*Cutter*" signifies swaggering bully: a cutpurse (A. W. Ward). See *How a man may Choose a Good Wife from a Bad*, Act v. Sc. 1: "Sir, do you not pink doublets?...I took you for a Cutter, you are of a great Kindred."—Roger North, in his *Lives of the Norths*, vol. 11. p. 57 (ed. 1826), says of Laurence Hyde, Earl of Rochester (the "Lory" of Dryden's *The Young Statesmen*), that one of his infirmities was "passion, in which he would swear like a cutter." (A. W. Ward's *History of English Dramatic Literature*, vol. 111. ch. ix. p. 327 note.) It would be an interesting sociological problem to trace the evolution of "cutting" through literature down to its modern sense. Cf. *The Art of Cutting* (early 19th century).

Have not the Foyle (56). So in Ben Jonson's *Discoveries*, where he says "the multitudine commend Writers, as they do Fencers, who if they come in robustously...are received for the *Braver-fellows*...when a slight touch of their Adversary gives all that boisterous Force, the foile."

"The fame of a gentleman that carieth weapon, yf it once take a foile in any little point through dastardlines or any other reproche, doeth evermore continue shameful in the worlde."

The Courtier, Sir T. Hoby, 1561.

"*Emperor*. Bestir thee Jaques, take not now the foil
Lest thou dost lose what foretime thou didst gain."

Friar Bacon and Friar Bungay, Sc. ix.

Also *I Henry VI*. v. 3. 23.

To foil is from the O.Fr. *affoller*, Ital. *affollare* to press hard.

Foxe (141). "The wolf-mark of the Passau sword-smiths was borrowed from the city arms, which consist of 'Or, a wolf figure,

stantant gardant.' Later, and especially in the 16th century, this mark was adopted in other places, and especially by Solingen smiths. These blades were known as 'foxes,' in England, doubtless from the 'wolf' inscription."

R. C. Clephan, *The Defensive Armour and Weapons and Engines of War &c.*, p. 172.

"Passau and Solingen were celebrated at a very early time for making blades of weapons, the quality of which was as highly esteemed as those of Toledo....Another very usual mark is a wolf, which is believed to have been granted by the Archduke Albert in 1349 to the Armourers' Guild of Passau: it is also to be seen on some of the earlier arms made at Solingen, in which city the armourers Clement Horn and Johann Stopp flourished at the commencement of the sixteenth century."

Auguste Demmin, *History of Arms and Armour*, Bohn, p. 548.

A reproduction of the wolf-badge is given by Demmin, p. 551. Those who have seen the rude outline of the wolf in question will easily understand its metamorphosis into an English fox.

Fox (141). "No more truth in thee than in a drawn fox," 1 *Henry IV.*, III. 3. 129. Dyce's *Glossary* (1902) misses the double meaning.

(Nares) "O what blade is it,
A Toledo or an English Fox?
Old foxes are good blades."

Defendant (113). A word now passed into the peaceful lists of the law-court, but quite common amongst the Elizabethans, as e.g.:

"All which arriv'd at the evenest piece of earth
The field afforded, the three challengers
Turn'd head, drew all their rapiers and stood rank'd.
When face to face the three *defendants* met them,
Alike prepar'd, and resolute alike.

Action of Battery (114). "Assault and Battery be for the most part an accomplishment of that which menace did threaten, and a performance by deedes of which the other fore-warned by words, that is to say, a violent and forcible abusing, or attempting to abuse by blowes and stripes the person of another, contrary to the peace of the realme. the law hath devised a quiet and peaceable course, to reduce him again to order, in punishing him by an action of Trespass of Assault and Batterie, wherein being convicted, hee shall satisfie the party griev'd his damages and pay to the King a fine, and his bodie shall be committed to prison untill hee hath satisfied it."

Swash-buckler or *Swinge-buckler* (120).

"He has ne'er a sword and buckler-man in his Fair."

Swash-buckler. "A vain-glorious Sword-player or Fencer; a meet Braggadochoe, a vapouring fellow."

To swash, "to make fly about; to clash, or make a noise with Swords." Ed. Phillips' *New World of Words*, 1657.

"To Swash it in apparell."

Antony Wood, I. 423 (ed. 1706). (A. Clark.)

Basket-Sword (154). The basket-hilt was first introduced in the Venetian Schiavona for the Schiavoni or Doge's guards of the sixteenth century. R. C. Clephan writes: "Scottish broadswords with practically this hilt... are often erroneously called 'claymores,' while, as a matter of fact, the Scottish weapon so called was a long two-handed sword, with quillons usually bending diagonally upwards...and it is considered questionable by some authorities whether any basket hilted sword whatever was in general use in Scotland long before the 18th century began."

Basket Hilt is the name of one of the characters in Ben Jonson's *Tale of a Tub*, and *Puppy* meeting him in "The Fields near Pancras,"

and retorting upon a threat of his "school-dagger 'bout your costard," says:—"Tie up your bredred bitch there, your dun rusty, Pannier-hilt poniard."

Basket-Sword (154). "What would you have sister, of a fellow that knows nothing but a basket-hilt and an old fox in it?"

Ben Jonson, *Bartholomew Fair* II. 6.

(See note on *Fox*, p. 64.)

"...as flat as a basket-hilt dagger."

Nat. Field, *Amends for Ladies*.

Basket hilt is one of the characters in John Cooke's *Greene's Tu Quoque or the Cittie Gallant*, published by his friend Thos. Heywood, 1614, 4°.

Morglay (158). "It is the most fortunate weapon that ever rid on poor gentleman's thigh. Shall I tell you, Sir? You talk of Morglay, Excalibur, Durindana, or so; but!...this a Toledo! Pish!...A Fleming, by heaven! I'll buy them for a guilden apiece."

Captain Bobadil; Ben Jonson, *Every Man In His Humour*, Act III. Sc. 2.

"The name *Morglay* was often given to a sword in general. Mr D. P. Fry suggests that *mor-glai* is merely an inverted form of *Clay-more*, the Celtic for *big sword*."

H. B. Wheatley (note to *Every Man In His Humour*).

"And how fair Iosian gave him (Sir Bevis) Arundel his steed
And Morgley his good Sword." Drayton's *Polyolbion*.

Bevis of Southampton (158). For this famous Romance see Ellis's *Specimens* and the Publications of the Early English Text Society. "There is as much difference betwixt these two kind of fights, as there is betwixt the true picture of Sir *Bevis of Southampton* and Sir *Bevis* himself, if he were living." Silver's *Paradoxes*.

The Draggon in Sussex, the other day (161) refers to "A strange and monstrous Serpent or Dragon," the subject of a pamphlet by A. R.

(printed at London, by John Trundle, 1614, and reprinted by Mr Charles Hindley in *The Old Book Collectors' Miscellany*, vol. II.) describing the appearance "in Sussex, two miles from Housam, in a Wood called 'St Leonard's Forrest,'" August 1614, of a serpent "reputed to be nine feet, or rather more, in length and shaped almost in the form of an axle tree of a cart, a quantity of thickness in the midst, and somewhat smaller at both ends....He will cast his venom about four rod from him, as by woful experience it was proved on the bodies of a man and woman coming that way, who afterwards were found dead, being poisoned and very much swelled, but not preyed upon." The story is certified by John Steele and Christopher Holder, and the carrier of Horsham, who lieth at the White Horse, in Southwark, but they do not disclose the name of the Sussex St George.

Gentleman. Arms (149). *The Booke of Armorie* (155). I have looked through Dame Juliana Berners' (Bernes or Barnes) "ryght noble Treatise of the Lygnage of Cot Armour" (1496), John Ferne's *Blazon of Gentrie* (1586), W. Wyrley's *True Use of Armory* (1592), John Guillim's *Display of Heraldrie* (1610), Robert Glover's *Catalogue of Honour* (1610), and Edmund Bolton's *Elements of Armory* (1610), and am inclined to believe that Gerard Legh's *The Accedens of Armory* (1562) is the Booke of Armorie referred to in the text—unless it be the 1595 edition of *The Book of St. Albans* revised and much altered by Gervase Markham and re-issued as *The Gentleman's Academie &c.* 4°. At any rate the following excerpts from Legh are "germane to the matter" of "the better Gentleman"—since he differentiates nine "genera":—

There are nine gentlemen of sundry callinges.....The first is a gentleman of auncestrie, which must nedes be a gentlemã of blood. But if he dye withoute issue, the whole cote armour is lost,.....The second, is a gëtleman of blood, and not of auncestrie. As, when he is the seconde in degree, descended from the first of that name. The third is a gentleman of cote armour, and not of blood. That is to saye, a gentleman of cote armour of the kinges badge, as the kinges devise geuen hym by an Herechaughte.....The fourth is also a gëtleman of cote armour, and not

of blood, as this. The king geueth a lordship by patent, to him and his heyres for euer. He may beare the cote of that lordship.....The fift, is a yeoman, a christian man. If he (I say) in the seruice of god and his prince, kill an heathen gentleman, of what degree soeuer he be (a knight baneret excepte) he shall beare the armes, and use his atchieuemēt without any differēce, sauīg only ſ̄ word of ſ̄ same miscreant gēlemā.....The sixt is, if a king do make a yeomā a knight, he is thē as a gēleman of blood, by ſ̄ royaltie of ſ̄ king, and knighthod. The seūth, is a gēleman spirituall. This, if he be a chorles sōne, and is aduāced to any spiritual dignitie, he is thē a gēlemā, but not of blud. But if he be a doctor of ſ̄ Ciuil lawe, he is a gēlemā as of blood, and his cote is perfit at ſ̄ first hearing. The eight, is called a gentlemā vntrial, and such is he, as being brought vp in an Abbey, or w^t a bissshop.....The nynth, hath ben of olde called a gentilmā Appocrifate. This is suche a one, as serueth a prince. And at his begynnyng, is a page, and groweth vp by his diligence, to be a grome, and so hyer.

“There was never gentleman nor churle ordained but hee had father and mother: Adam and Eve, had neither father nor mother and therefore in the Sonnes of Adam and Eve first issued one both gentleman and churle....”

(Noah to his son Japhet):

“Adams Sonne, I make thee a gentleman, and thy renoune shall streth through the west part of the world...and thy dominion shall be called Asia, which is the countrie of gentlemen....From the of-spring of gentlemanly Japhet came Abraham, Moyses, Aaron and the Prophets and also the king of the right line of Mary, of whom that only absolute gentleman Jesus was born...and gentleman by his mother Mary princesse of coat armour.”

“*The Booke of Armorie, The Gentleman's Academie, or The Booke of S. Albans...* compiled by Juliana Bernes (1496) and now reduced into a better method by G(ervase) M(arkham).” London, 1595.

Maister of Defence (183). The Elizabethan name for a Fencing Master: there was a Guild or *Mystery* of them (see Prologue, p. 23).

“My profession said *Vincenio* (Saviolo?) what is my profession. Then said the gentleman, he is a Maister of the noble science of Defence.” “I speak not against Maisters of Defence indeed, they are to be honoured, nor against the Science, it is noble, and in mine opiniō to be preferred next to Diuinitie; for as Diuinitie preserueth the soule from hell and the diuell, so doth this noble Science defend the bodie from wounds and slaughter.”

“The Dagger serueth well at length to put by a thrust, and at the halfe Sword to crosse the Sword-blade, to driue out the Agent, and put him in danger of his life.” Silver's *Paradoxes of Defence*.

The equivoque in the text (183) consists in the dagger being always used to parry or ward off the blow.

Fencing School (182). “For of fence, almost in every town, there is not only masters to teach it, with his provosts, ushers, scholars and other names of art and school; but there hath not failed also, which hath diligently and favouredly written it, and is set out in print, that every man may read it.

Philologe. But in learning of fence, I pray you what is that which men most labour for?

Toxophilus. That they may hit another, I trow, and never take blow their self.

Fencing-Schoole. “Like him, who thought to come to bee a good Fencer by looking on *Agrippa's* [or *Don Luis de Nervins*] book-postures only.”

the cost of our lives before we know it; it were requisite according to the order of true discipline, we should preferre the theorike before the practike. We betray our apprentissage."

"Like the Usher of a Fence-schoole, about to play his prize."

Archery (185). "Amongst all the English artillery, *Archerie* challengeth the pre-heminence...first shewed to the English by the *Danes*, brought in by the *Normans*, continued by their Successors to the great glory of *England*, in achieving honourable victories; but now dispossessed by gunnery, how justly let others judge. Much may be said for either."

"In Praise of Archery.

Brave Archery, what rapture shall I raise

"In the days of *Queen Elizabeth* of thrice happy and blessed memory, when the use of the *Musquet* was newly brought from beyond the Seas unto this Kingdome, and the vertue thereof found and approved; yet was the weapon so scarce to be had, workemen so slow, and new alterations so unpleasant, that the State was compelled to compound their Bands of three severall Weapons, the *Pike*, *Musquet*, and the *Harquebush* or *Calliuer*, as I am able to shew by sundry lists."

NOTE. I would recommend to Toxophils the issuing a facsimile of this charming little 32mo with its old woodcut frontispiece of a Bowyer in action.

Bow, Bill and Gun (185). "In like maner when occasion is ministred to speak of shoting or archeri, we Englishmen may cal it the honour of our Country...Therefore it shal become al gentlemen to use this our English pastime of shoting for their greatest game and disport...Furthermore yf wee compare the warres of tymes passed wythe those whiche haue beene, synce the inuencion of the Gunne, we shall perceiue that the Valiency of men touching right manhead hath bene nothing like unto that auncient time."

The Institucion of a Gentleman, 1568.

Bow Bill. Invert the words and you have another pun 'Billbow,' a fine Spanish blade manufactured at Bilbao.

"When down their bows they threw
And forth their *billbows* drew."

Drayton's *Battle of Agincourt*.

"*Scholar*. What handling is proper to the instruments?

Toxophilus. Standing, nocking, drawing, holding and loosing, whereby cometh fair shooting, which belongeth neither to wind, nor weather."
Ascham.

"For some shall maintain that a Turk can be hit at twelve score pricks in Finsbury Fields. Ergo the bow and shafts won Boulogne; others say that a pot-gun is a dangerous weapon against a mud-wall, and an enemy to the Painter's work."

Taylor's *Penniless Parliament of Thread-Bare Poets*, 1608.

Any man may bend him as he list (190). "But again in stringing your bow, you must look for much bend or little bend, for they be clean contrary."

Ascham's *Toxophilus*.

Nocke (194), cf. the ballad *St George for England* by John Grubb, M.A., 1688, wherein King Arthur's sword "y-cleped Caliburn" was said to

"Split a man at single slash
From noddle down to nock."

Nocke stands for "brech": which, the talk being of guns, might be taken by the less vulgar-minded as an Academic *a posteriori* prediction of the long delayed invention of the Breech-loader.

Nocking the Arrow is the time-honoured phrase for notching the arrow, see Hansard's *Book of Archery* 1896, where the process of "nocking" ("shifting your shaft-hand down to the nock") is fully described.

"The nocke of the Shaft is diversly made, for some be great and full, some handsome and little, some wide, some narrow, some deepe, some shallow, some round, some long, some with one Nocke, some with a double Nocke whereof euery one hath his seuerall property."

"First in putting the Nock betweene your two first fingers, then bringing the Shaft under the String and over the Bow, then to set the Shaft neither too high nor too low, but euen and straight ouerthwart the Bow."

Bill (195). "The Forrest Bill is a double weapon by reason of the head, and therefore hath eight wardes, foure with the staffe, foure with the heade."

"The Welch hooke or Forrest Bill, hath advantage against all maner of weapons whatsoever."

"The Halbard or blacke Bill, or such like weapons of weight, apertaining unto guard or battell." Silver.

"When English men used *Hercules* weapons, the bow and the black bill, they fought victoriously with *Hercules* success: so I hope they shall carry way no victory more happily now, when they adjoin to those weapons of *Hercules*, *Ioue's* thunder-bolt; for so some now call our greatshot." Camden's *Remaines*, 1605.

"*The Bill* (A.-S. *byll*, Irish *biail*, *securis*, German *Beil* = Axe) was introduced into England *temp.* Henry VI. about the fifteenth century, when it was allied in form to the Halbard. Skinner considers it a *securis rostrata* (beaked axe). It was long a favourite in Scandinavia, and the illustration (Fig. 101) represents the weapon of Gunnar, the Icelandic Champion, which sang before battle, as also did the Sword of Sigard."

Bill's a Tall-fellow ons hands (200). "As he lived in a ruffling time, so he loved sword and buckler men, and such as our Fathers were wont to call men of their hands."

wherein you may conueniently strike, thrust and ward, and that is the just length to be made according to your stature."

Ben Jonson has the same pun in *The Staple of News* upon the duns of Pennyboy Canter:

"Cardinal Wolsey, I say, waxed so wood therewith, that he studied to invent all ways of *revenge*ment against the Emperour."

(Francis Bacon was one of the Subscribers to this work, the first which contained a printed list.)

Gunne (203). "The earliest mention of hand-guns occurs in connection with Perugia as early as 1364 (Clephan). The first portable fire-arm, or small hand-cannon, is of the same date as the breech-loading cannon, both being invented at the beginning of the 14th century." Demmin. (See note to *Flash*, p. 77.)

"Yet of all weapons, the best is, as Euripides doth say, wherewith with least danger of ourself, we may hurt our enemy most. And that is, (as I suppose) artillery. Artillery now-a-days, is taken for two things, guns and bows." Ascham.

"And therefore banish not onely from your Court all traitorous offensive weapons, forbidden by the Lawes, as guns and such like... but also all traitorous defensiu armes, as secrets, plade sleeves and such like unseene armour¹." James I., *Basilikon Dron*.

"Having names given them, some from Serpents or ravenous birds, as Culverines or Colubrines, Serpentine, Basiliques, Faulcons, Sacres; others in other respects as Canons, Demi Canons, Chambers, Slingis, Arquebuze, Caliver Handgun, Muskets, Petronils, Pistoll, Dagge &c. and Petarvas of the same brood lately invented."

Camden's *Remaines*, 1605. (Artillerie)

"True it is that Mosquets being in the hands of skilful Mosquettiers are of great effect for divers purposes; and that kind of weapon of that length with restes, and so ranforced, was first used in *Italie* above 60 years past (i.e. circa 1530) as I have divers times heard auncient Capitaines of the *Italian* and *Spanish* Nation say."

He continues: "the Duke of Alva when Governor of the Low Countries increased the number of Foot Musketeers to counteract the effect of the *Ratters*" (? Reiters).

Sir John Smythe, *Discourses* etc. (see note on p. 28 for full title).

Bouncing (202). Ben Jonson of a woman:

"A very *bona Roba* and a Bouncer."

The New Inn, Act III. Sc. 2.

"Is your Italian the finest gentleman?—In the world, Signor. Your Spaniard is a mere Bumbard to him: he will bounce indeed but he will burst." Heywood's *Four Prentices*.

Here bounce signifies the recoil of a piece of ordnance (Bumbard), much as in the text, and our modern "Boulder" may be derived from the rebound or 'bounce' of the Elizabethan gun.

Dagger in Cheape (285).

In a Descriptive Catalogue of the London Traders, Tavern, and Coffee-House Tokens current in the 17th Century, by J. H. Burn, 1853, we find the following:—

"At the Dagar and (Pie). A Dagger; magpie on point. Reverse: Pye in Foster Lane (Cheapside). In the field M. H. D."

"Richard Smith, in his Obituary, Sloane Ms. 886, records:

Decr. 22, 1657, Moses Dannel at ye Dagger in Foster Lane buried."

I have come to the conclusion that the "Dagger in Cheape" (far less frequently mentioned in Elizabethan literature than its namesake in Holborn) must have been situate in Foster Lane, Cheapside: see Notes on "Dagger," "Dagger Ale," &c.

"O gentle fellow-soldiers, then leave your controversies, if you love a woman, for I will prove it that a mince-pie is better than a musket; and he that dare gainsay me, let him meet me at the Dagger in Cheape, with a case of pewter spoons, and I will answer it."

Taylor's *Pennilesse Parliament of thread-bare Poets*, 1608.

"2nd *Pren*. I must needs step to the Dagger in Cheap to send a letter into the Country unto my Father. Stand by; you are the youngest 'prentice, look you to the shop."

"...Ten pounds in a morning? here's the fruit

Of Dagger-pies and ale-house guzzlings."

"In Vol. 2 of *Extracts from the Stationers' Registers*, p. 171, is mentioned the publication of *A fancie on the fall of the Dagger in Cheap*, which may mean either that the house, or the sign which it bore, fell down; probably the latter, although the Editor, in his note on the entry, supposed that the word 'fall' applied to the house."

J. P. Collier's Note.

There was another "Dagger" in Holborn frequented by gamblers and sharpers (Nares) celebrated for its Dagger-pies and Dagger-ale (see B. Jonson's *Alchemist* i. 1, Fulwell's *Art of Flatterie*, *Witt's Recreation*, and Gascoigne's *Del. Diet for Drunkards* and Dekker's *Satiromastix*).

In Greene's *Arcadia or Menaphon* he speaks of "Dagger Drunkenness" on a "pot of blew burning ale, with a fiery flaming toste." Egerton Brydges' *Censura Litteraria*, vol. vii. p. 165.

Gunpowder Plot. 1605 (228). In a tract dated 1606 (reprinted in C. Hindley's *Old Book Collectors' Miscellany*) on the Arraign and Execution of the late Traitors (four at St Paul's Churchyard on Thursday 30th Jan., and four in the old Palace in Westminster over against the Parliament house on Friday following), "Fawkes, the minor, justly called, the Devil of the Vault" is spoken of as "alias Johnson."

Powder (209). "When the Letter was shewed to me by my Secretary, wheren a generall obscure aduertisement was given of some dangerous blow at this time, I did upon the instant interpret and apprehend some darke phrases therein, (contrary to the ordinary Grammer construction of them, and in an other sort then I am sure any Divine, or Lawyer in any Universitie would have taken them) to be meant by this horrible forme of blowing us all up by powder."

K. James I., A speech in Parliament, 1605.

"*Pen*. If you cross him, he'll blow you up with gunpowder.

Abra. In good faith, he looks as if he had had a hand in the treason. I'll take my leave."

Nat. Field, *A woman is a weathercock*.

Parliament House (230). "Surely if I were one of the Parliament-house, I would not fail to put up a bill for the amendment of this thing."

Ascham's *Toxophilus*.

Flash (219). "Sir Petronel *Flash*" was a name given to a Braggadocio or boasting fellow.

"*Pietranelli* souldiers serving on horseback armed with *petronels*, snaphances or fire-lock pieces and cuirasses." (Florio.)

"Petronel (from *Poitrinal*) = Hand-Cannon for a Knight."

H. B. Wheatley's Note to *Every man in his Humour*.

Shyre (223). See Thos. Hearne's *Curious Discourses* (Of what antiquity Shires were in England) by Several Hands.

"The other House is composed of Knights for the Shire and Gentry, and Burgesses for the Townes."

James I. A speech in Parliament, 1605.

On the 27th Nov. 1616 that prince of hack-writers (and riders), Gervase Markham, was censured in the Star Chamber and fined in the sum of £500 for sending a challenge to Lord Davey. The quarrel between them arose from his Lordship's dog "Bowser" having been "in danger to be trodden on" by Markham at a hunting party at Sir Gervase Clifton's. Opinions were delivered by the King's Attorney, the Chancellor of the Exchequer, the Lord Chief Justice, Secretary Winwood, the Vice-Chamberlain, the Bishops of Ely and London, the Master of the Wards, Lord Arundell, the Lord Treasurer, the Archbishop of Canterbury and the Lord Chancellor. *Censura Litteraria*, vol. III. p. 64. See curious anecdote of encounter between G. M. and Sir John Holles in 1597 in *Theatr. Poet. Ang.* (279—80), copied from Collins's *Noble Families* 84, 5.

See also 2 *State Trials* 743 and Prologue (p. 29) for the prosecution of Lord Sanquhar for the murder of the Fencing Master (Turner) "who had accidentally put out one of the northern Pier's Eyes in playing at Rapier and Dagger," in which Bacon as Solicitor General conducted the prosecution.

Backe-Friend to us both (257). So Hobbes of Chillingworth: "A lusty fellow that would drive his enemies before him; but would often give his own party a shrewd backblow."

Long Sword (287). "Logic is the armoury of reason, furnished with all offensive and defensive weapons. There are syllogisms, long swords; enthymemes, short daggers; dilemmas, two-edged swords, that cut on both sides; sorites, chain-shot; and for the defensive, distinctions, which are shields; retortions, which are targets with a pike in the midst of them, both to defend and oppose."

Thos. Fuller, D.D., *The Holy State* (The General Artist).

Also, "Fencing is war without anger; and manly sports are the grammar of military performances." *Ibid.* "Of Recreations."

Field and Fields (37), (242). These words so frequent of occurrence have a general and special sense: *the field*, generally, standing for the field of combat or *terrain*; and *Fields* being the unbuilt-over spaces in and around London, especially on the North side. If we look at Ralph Agas's Map of London (*Civitas Londinum*) date about 1560, we see that the Fields bounded the whole of the North side of London, behind Holborn: there, in order, we find *Schmyt Eyeld* (Smithfield), *More Eyeld* (Moorfields), *Fynesbury Eyeld* (Finsbury Field) and *The Spurl-Eyeld* (Spitalfields), of which we learn the following particulars from Stow and other sources:—

Smithfield or *Smoothfield*, the *planus Campus re et nomine* of Fitzstephen.

"And this Sommer 1615 [the year of our play] the City of London reduced the rude vast place of Smithfield into a fair and comely order, which formerly was neuer held possible to be done, and pauer it all ouer...they also made strong rayles...and sequestered the middle part of the said Smithfield into a very faire and ciuill walk...And this field was for many yeares called 'Ruffian's Hall,' by reason it was the usual place of frays, and common fighting during the time that sword and bucklers were in use. But the ensuing deadly fight of Rapier and Dagger suddenly suppressed the fighting with Sword and Buckler."

"I'll buy this i' the field, so I will; I have a mind to it, because 'tis a field rapier."

"Neither to look back to the Sword and Buckler age of Smithfield, but content himself with the present."

Stowe notes the encroachments and enclosure of this S., "whereby remaineth but a small portion for the old uses; to wit for markets of horses and cattle, neither for military exercises, as joustings, turnings and great triumphs, which have been there performed before the princes and nobility, both of this realm and foreign countries" [see Froissart].

St Giles in the Fields. "Ye may read in mine annals how that in the year 1222 the citizens kept games of defence, and wrestlings, near unto the hospital of St Giles in the field, where they challenged and had the mastery of the men in the suburbs and other commoners... The youths of this city also have used on holy days after Evening prayer, at their masters' doors, to exercise their wasters and bucklers." Stow's *Survey* p. 36. Strutt, *Sports and pastimes* Bk III. Chap. VI. Sec. 22, gives an engraving of this.

Tothill Fields (or Fields, on the south side of the Thames). Minshew's Dictionary 1617.

"*Speddall*. And I will meet thee in the field as fairly
As the best gentleman that wears a Sword.

Stainer. I accept it: the meeting Place?

Speddall. Beyond the Maze in Tattle.

St. What weapon? *Sp*. Single Rapier."

Greene's Tu quoque, published by Thos. Heywood, 1614.

Fields. "It is also a kind of dastardliness which hath brought this fashion into our single combates, to accompany us in the fields with seconds, thirds and fourths. They were anciently single combates, but now they are skirmishes and battels."

Florio's *Montaigne* Bk II. chap. xxvii.

(*Cowardize the Mother of Cruelty*.)

Moorfields. "This field of old time was called the More, as appeareth by the Charter of Wm. the Conqueror to the College of St Martin, declaring a running water to pass into the City from the same More. Also Fitzstephen writeth of this More saying thus: 'When the great Fen or moor, which watereth the walls on the North side is frozen &c.' This fen or moor field, stretching from the wall of the city betwixt Bishopsgate and the postern called Cripples gate to Fensbery and to Holy Well, continued a waste and unprofitable ground a long time [but in the year 1415 the Mayor built the postern called Moregate and caused the ditches to be cleansed and so drained and dried the fen]. In the year 1498 all the gardens, which had continued time out of mind without Moregate... were destroyed; and of them was made a plain field for archers to shoot in" [they may be descried in Agas]. Stow's *Survey*.

It was one of the chief resorts for duelling:—

"Walk into Moorfields.

I dare look on your Toledo. Do not shew

A foolish vapour in the Streets."

Massinger's *City Madam*.

Pepys stood and saw the wrestling there in 1661 and tells of the fray between the butchers and the weavers in 1664. It was the mustering ground of troops. Shadwell mentions cudgel-players and Tom Brown the second-hand booksellers under the trees, while Keats was born at livery-stables on the Pavement in Moorfields.

Finbury or *Fensbury* without the posterns of Cripplegate and Moorgate lent its name to the Square and Circus which subsequently overspread Moorfields. Grub Street was hard by, "of late years inhabited for the most part by bowyers, fletchers, bowstring makers and such like occupations, now little occupied; archery giving place to a number of bowling alleys, and dicing houses, which in all places are increased and too much frequented." Stow.

The first Playhouse in London, "The Theatre," was erected in

Finsbury Fields in 1576, see *Early London Theatres (In the Fields)* by T. Fairman Ordish, F.S.A., who quotes from *Remembrancia* some interesting notices of fencing and sword play.

Velvet (275). See note to *Gilt* on p. 58, also on p. 20.

Justice of the Peace (101). James has himself told us how highly he valued the services of a Justice of the Peace, and we might almost suppose Dagger to have had an inkling of this from the dramatic effect of his announcement:

So let the Judges bee neuer so carefull and industrious, if the Justices of Peace vnder them, put not to their helping hands, in vaine is all your labour: For they are the Kings eyes and eares in the country... For I hold a good Justice of Peace in his Country, to doe mee as good seruice, as he that waites vpon mee in my Priuie Chamber, and as ready will I be to reward him; For I accompt him as capable of any Honour, Office, or preferment about my person, or for any place of Councell or State, as well as any Courteour that is neere about mee, or any that have deseried well of me in forreine employments: Yea, I esteeme the seruice done me by a good Justice of Peace, three hundred miles, yea sixe hundred miles out of my sight, as well as the seruice done me in my presence: For as God hath giuen me large limits, so must I be carefull that my prouidence may reach to the farthest parts of them. And as Law cannot be honoured, except Honour be given to Judges: so without due respect to Justices of Peace, what regard will be had of the seruice?

Therefore let none to be ashamed of this office, or be discouraged in being a Justice of Peace, if he serue worthily in it.

Philaletes. Right. And from thence I infer, That Duelling is a very dishonourable Practice. For when you have given the best Proof of your Sufficiency, and killed your Man, you are seized into the Hands of Justice; treated like Assassins: and condemned to Die with Circumstances of Ignominy. You are not indicted for acquitting yourselves like Gentlemen; but for disturbing the Publick Peace, and murdering the King's Subjects. Now the Law never loads a Man with Reproaches, nor punishes him thus coarsely, for doing a handsome action.

So that it alwaies had a vigilant eye by anticipation to prevent many others that would breake the peace by any of the meanes aforesaid, and therefore hath from age to age appointed meet magistrates and watchmen, to whose charge especially (as Selected Sentinells) they bid commit the preservation of the peace, who in times past

before the raigne of King Edward the Third, were called Conservators of the peace, and thence they have been termed Justices of peace, because they be Justices of Record, or otherwise they be named Commissioners of the Peace, because they have and derive their authority by the King's Commission who himselfe being the chiefe and generall Conservator and Preserver of the peace throughout all his dominions, doth by his severall Commissions commit some particles of his authoritie, touching the continuance of the peace, and maintenance of certain of his Lawes, to some chiefe and select men in all the parts of the Realme, whom hee taketh to bee the most mieste men for the same in respect of their integrity, wisdome, learning, courage, and livelyhood.

Our purpose is out of the sense of Honour, to extend Our punishment as far above those ordinary degrees, which are now in vse, as the facts themselues exceede all humanitie. For though the differences betweene greater and lesser occasions and motiues cannot bee denied, and the *Civilians* distinguish by their Lawes betweene Blowes that smart, or smart not; yet since that scorne holdes a Gentleman well borne, and sutable behaued, worthy the chastisement of a dog, this onely respect ought to bee preferred to the smart that is felt by the seneces.....

This *Striker* shall condemne vnder his owne hand, before hee bee suffered to depart out of restraint, that saucie *Paradox* which giues liberty to Gentlemen with their owne Swordes to reuenge wrongs done to themselues. Hee shall further promise solemnly before the Lords, neuer to offend vpon the like occasion, in the like contempt. Hee shall be bound to the good Behaviour during the space of the next sixe Moneths that ensue, and during the same terme likewise abstaine from Our Court, and from all places where the *Queene* our dearest Spouse, and the *Prince* Our dearest Sonne shal happen to reside. For it is true that *Palaces* of this qualitie, should rather serue for so many *Sanctuaries* to distressed Subjects that endure wrong, then receptacles or retraits for persons of vnstayed iudgement, that offer it. Last of

all, Wee leaue the person that was hurt or stricken, to the benefit of his action of *Battery* at the Common Lawe, with a meaning, that Our Censures be reputed rather *cumulatiue*, then *priuatiue*, of any lawfull help that Iustice yeeldes, vnlesse the Lordes can deuise by their discretion at the cleansing of the wound, to purge all motiues that may cause it by succeeding accidents, (that rancle and renew) to breake out againe.....

For triall of the maine point, after Gentlemen haue agreed to trie the Quarrell by their Swords in the Field, it is considerable whether both of them be slaine or neither. For in euery one of these, the diuersitie of Degrees draws in likewise a great difference betweene the courses that are to bee obserued by the Lords, and their Deputies. Touching the partie slaine after *Challenge* in cold blood by single Fight, in despite of Our decree, or in case the match consist of many, touching all those that are slaine, Our part is onely to leaue them to the Iustice or Mercie of their *Eternall Iudge*.....

In excuse of Seconds, it is said by some, that they were onely brought in as vsfull instruments to paire weapons, to search bodies, to depart the *Combatants* vpon equall tearmes, to suppress aduantage vpon either side, and to see faire play: yet since the Fight it selfe is absolutely bad in it selfe, it is not possible for any acte assisting, or abetting, whatsoever cloud be cast vpon a tender eye, to bee iust, or in a matter of this weight to warrant accessaries, when Wee taxe the principall. These Seconds in very deed, to make the best of them, are onely stout Assistants to bad ends: their fairest actions are but formall preparations: their excuses are but shadows: though they see the sinner, yet they runne with him. If wee marke well, their labours and endeouours are of little vse: For whatsoever be expected of their Humanitie, their Charitie and Care; yet whosoever vndertakes to moderate men in fight will not forbear, either vpon the sight of blood, or the sence of smart, to rush desperately vpon extremities. These Seconds might perhaps serue better to some ende, in case the prosecution of priuate Quarrels by the Sword, were first admitted and approoued by any *Prince* or *State*: But since they shrinke that should bee the Supports and Stayes, it is not strange, that *Sublato Principali, omnia cadunt accessoria*: Betweene an Actor therefore and an Abettor, the difference cannot bee great, howsoever malice may be masked vnder false couers.....

The better to bring Quarrels to discouerie, when they begin first to worke, it is obserued, that not onely in the common Ordinaries, to which Gentlemen doe vsually resort, but sometimes also in the Tennis Courts, in bowling Allies, Dicing houses, and all houses of game, questions sometimes vpon a cast, sometimes vpon distemper in losse, vpon refusall to lend vpon importunitie to be paid, vpon termes of comparison, and words of exception, vpon as many contingents, as places of that nature breed vexations and contradictions.....

For remedie whereof, Wee doe straitly charge and command; First Our owne Groome-porter, and then all other keepers of gaming-houses, of Tennis Courts, and bowling Allies, vpon paine of Our high displeasure, beside three months commitment and suspension of their power, to keepe houses of resort to that end, for the space of three whole yeeres at the least, that instantly vpon the giuing of any reproachful word, or passing any blow betweene Gentlemen, that are likelie to seeke a sharpe reuenge by the sword, in some place more priuate, their first care bee to take the weapons of the persons kindled with rage, if it may be; the next to keepe them in sunder till some Officer of the Peace be brought into the place to command in Our name, till the Quarrell comming to the hearing of the Lords in Commission, may receiue a sharper censure, or a better satisfaction, as they in their graue Iudgements shall finde, both the persons to deserue, and the cause to be considerable.
